BACKGROUND INFORMATION/FISCAL IMPACT:

This bill would allow certain federally certified businesses whose principal address, principal place of operation, or domicile is within Prince George's County to use that status to meet County-based business certification requirements of the County-based Small Business Assistance program, and extend the validity term of the certification from two (2) to three (3) years. It would also create less cumbersome requirements for certification as a Locally-owned and Operated Business, and rename the County resident-owned business preference to be the Locally-owned and Operated Business preference.
