RESOLUTION

1 A RESOLUTION concerning

2 Local Impact Grant Funds Multiyear Plan

3 For the purpose of approving the County’s Local Impact Grant Funds Multiyear Plan.

4 WHEREAS, Section 9-1A-31 of the State Government Article of the Annotated Code of
5 Maryland provides that prior to any expenditure of local impact grants funds provided under
6 Section 9-1A-27 of the State Government Article of the Annotated Code of Maryland (allocation
7 of video lottery proceeds), a county or municipality shall develop, in consultation with the local
8 development council, a multiyear plan for the expenditure of the local impact grant funds for
9 services and improvements consistent with Section 9-1A-31(b) of the State Government Article
10 of the Annotated Code of Maryland; and

11 WHEREAS, Section 9-1A-31(b) of the State Government Article of the Annotated Code of
12 Maryland provides that local impact grants shall be used for improvements primarily in the
13 communities in immediate proximity to the video lottery facilities and may be used for the
14 following purposes: (i) infrastructure improvements; (ii) facilities; (iii) public safety; (iv)
15 sanitation; (v) economic and community development, including housing; and (vi) other public
16 services and improvements; and

17 WHEREAS, Section 9-1A-31 of the State Government Article of the Annotated Code of
18 Maryland provides that a county or municipality shall submit the plan to the local development
19 council for review and comment before adopting the plan or expending any grant funds; and

20 WHEREAS, Section 10-309.02 of the County Code provides that prior to submitting the
21 multiyear plan to the local development council for review and comment, the County Executive
22 shall transmit the multiyear plan to the County Council of Prince George’s County (the “County

1 Council”) for review and comment.

2 WHEREAS, Section 10-309.02 of the County Code also provides that the County Council
3 shall have thirty (30) days to review, comment and make recommendations on the multiyear
4 plan; and

5 WHEREAS, Section 10-309.02 of the County Code provides that the County Executive
6 shall make best efforts to accommodate the recommendations of the County Council prior to
7 submitting the multiyear plan to the local development council; and

8 WHEREAS, Section 9-1A-31 of the State Government Article of the Annotated Code of
9 Maryland provides that a local development council shall have forty five (45) days to review,
10 comment, and make recommendations on the plan; and

11 WHEREAS, the Council County reviewed, commented and made recommendations on the
12 County’s multiyear plan (hereinafter referred to as the “Local Impact Grant Funds Multiyear
13 Plan”) on January 28, 2016; and

14 WHEREAS, the local development council reviewed, commented and made
15 recommendations on the Local Impact Grant Funds Multiyear Plan on April 27, 2016; and

16 WHEREAS, the Local Impact Grant Funds Multiyear Plan was originally set forth as an
17 Attachment A, Attachment B attached hereto and made part hereof is more consistent with the
18 County Council’s prerogatives and will therefore replace Attachment A; and

19 WHEREAS, there are two options set forth and proposed for consideration at public
20 hearing, the total amount of available funds projected for FY 2017 remains \$4,502,100; and

21 WHEREAS, Section 10-309.02 of the County Code provides that subsequent to the local
22 development council’s review, comment and recommendations on the Local Impact Grant Funds
23 Plan, the County Executive shall transmit the Local Impact Grant Funds Plan to the County
24 Council for review and approval by resolution; and

25 WHEREAS, Section 9-1A-31 of the State Government Article of the Annotated Code of
26 Maryland provides that on request of a local development council, the county or municipality
27 shall hold a public hearing on the Local Impact Grant Funds Plan; and

28 WHEREAS, these grant funds are FY 2017 projections and any additional monies over
29 and above these projections (as reflected in the attached) shall remain subject to supplemental
30 appropriation of the County Council and the requirements of a resolution pursuant to Section 10-
31 309.02; and

1 WHEREAS, the FY 2018, 2019, and 2020 projected funding shall require a resolution
2 pursuant to Section 10-309.02 and any additional monies over and above those projections shall
3 remain subject to the supplemental appropriation of the County Council and the requirements of
4 a resolution pursuant to Section 10-309.02.

5 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
6 County, Maryland, that the Local Impact Grant Funds Multiyear Plan, set forth in Attachment B,
7 is hereby approved in accordance with the provisions of Section 9-1A-31 of the State
8 Government Article of the Annotated Code of Maryland and Section 10-309.02 of the County
9 Code.

10 BE IT FURTHER RESOLVED that the Local Impact Grant Funds Multiyear Plan may be
11 reviewed and amended as necessary, in accordance with Section 10-309.02 of the County Code.
