RESOLUTION

1 A RESOLUTION concerning

2 The Approval of an Application to Preserve Property pursuant to the
3 Maryland Agricultural Land Preservation Foundation Program

4 For the purpose of recommending that the Maryland Agricultural Land Preservation Foundation
5 approve the application of Michael and Linda Mersch and Larry and Patricia Richards to
6 permanently preserve their property.

7 WHEREAS, the application, dated June 27 & 30, 2011, by Michael and Linda Mersch and
8 Larry and Patricia Richards requested the permanent preservation of approximately 57.06 acres
9 (Tax Map 158/Grid F1/Parcel 12/Tax Accounts 04-0262295 and 04-0262287) located at 17020
10 River Airport Road in Brandywine, Prince George's County, Maryland, as generally shown on
11 the attached location maps; and

12 WHEREAS, the application was referred to the Prince George's County Agricultural
13 Preservation Advisory Board and the Prince George's County Planning Board for review and
14 recommendation;

15 WHEREAS, the Prince George's County Agricultural Preservation Advisory Board found
16 that Mersch and Richards property met the qualifying criteria for productivity, size and location
17 as set by the Maryland Agricultural Land Preservation Foundation, and recommended approval
18 of the application; and

19 WHEREAS, the Prince George's County Planning Board found that the application to
20 permanently preserve this property is compatible with existing and approved county plans and
21 recommended approval of the application on April 19, 2012; and

22 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's

1 County, Maryland, that Tax Map 158/Grid F1/Parcel 12/Tax Accounts 04-0262295 and 04-
2 0262287, as described in the application filed by Michael and Linda Mersch and Larry and
3 Patricia Richards is recommended to the Maryland Agricultural Land Preservation Foundation
4 for approval.

5 BE IT FURTHER RESOLVED that this resolution, copies of the application, maps and
6 copies of the letters from the Agricultural Preservation Advisory Board and the Prince George's
7 County Planning Board, be forwarded by the Clerk of the Council to the County Executive for
8 his consideration and, upon his approval, transmitted to the Maryland Agricultural Land
9 Preservation Foundation for appropriate action.
