BACKGROUND INFORMATION/FISCAL IMPACT:

This bill adopts the County's current expense budget and capital budget for the fiscal year 2016. It adopts an appropriations amount for the County's General Fund portion of the budget of \$2.95 billion, which is \$93.2 million, or 3.3% over the approved FY 2015 budget of \$2.86 billion. Overall, 66.7% of all General Funds are appropriated for Education (Board of Education, Community College and Memorial Library),

while Criminal Justice and Public Safety receive 21.2% of available funds. The remaining 12.1% of County General Funds, 8.6% goes to pay for fixed charges and debt service, leaving 3.5% for Human Services, Public Works, Environment and General Government. The budget also establishes appropriation authority for all operating funds, including grants, Internal Service funds, Enterprise funds and Special Revenue funds that, when combined with the General Fund, totals \$3.54 billion.
