BILL

1 AN ACT concerning

2 The Issuance and Sale of General Obligation Bonds

3 FOR the purpose of authorizing and empowering Prince George's County, Maryland, to issue
 4 and sell an amount not to exceed Eighty-seven Million Eight Hundred Seventy-four Thousand
 5 Dollars (\$87,874,000) in aggregate principal amount of general obligation bonds with serial
 6 maturities, including mandatory sinking fund installments in lieu of serial maturities; for the
 7 purpose of providing funds for financing in whole or in part costs of the construction,
 8 acquisition, improvement or extension of certain capital projects set forth in the capital budget of
 9 the County for the fiscal year ending June 30, 2000, or usable portions thereof, including
 10 describing the capital projects to be financed in whole or in part from the proceeds of the bonds
 11 hereby authorized and the estimated costs and probable useful lives thereof; prescribing the
 12 procedures for the issuance and sale of such bonds; providing for the consolidation of such bonds
 13 with other bonds for purposes of such sale; providing for the issuance and sale of such bonds at
 14 public sale; providing for the forms of such bonds; providing for the form of the Notice of Sale,
 15 summary Notice of Sale for publication and form of bid for such bonds to be used in connection
 16 with such sale; showing compliance with the power of the County to incur indebtedness;
 17 directing the application of the proceeds of such bonds; providing for the levy and collection of
 18 taxes necessary for the payment of the principal of and interest on such bonds when due;
 19 covenanting that the proceeds of such bonds (or any moneys which may be deemed to be such
 20 proceeds) shall not be used in a manner which would cause the bonds to be "arbitrage bonds" and
 21 covenanting on other matters relating to the tax exempt status of interest on such bonds;

1 providing generally for the issuance, sale and delivery of general obligation bonds of Prince
2 George's County, Maryland, and the consolidation of bonds and the establishment of a
3 borrowing program for the County and related matters; authorizing and empowering the County
4 to issue and sell an amount not to exceed Eighty-seven Million Eight Hundred Seventy-four
5 Thousand Dollars (\$87,874,000) in general obligation bond anticipation notes in anticipation of
6 the issuance and sale of such bonds; providing for the issuance of such bond anticipation notes in
7 the form of commercial paper; providing for the issuance of such bond anticipation notes and
8 such bonds in the form of variable rate demand obligations; providing for the issuance of such
9 bonds or notes in registered form, including central depository and book-entry arrangements;
10 providing generally for the issuance, sale and delivery of general obligation bond anticipation
11 notes of Prince George's County, Maryland, including bond anticipation notes in the form of
12 commercial paper and the consolidation of bond anticipation notes; authorizing and empowering
13 the County to issue, sell and deliver general obligation refunding bonds for the purpose of
14 refunding all or a part of such bonds, the proceeds of such refunding bonds to be used for the
15 public purpose of providing funds sufficient to pay principal of, redemption premium, if any, and
16 interest on such bonds, at the respective maturity, redemption, and interest payment dates of such
17 bonds; prescribing the procedure for the issuance and sale of, and the maximum principal
18 amount of, such refunding bonds; empowering the County Executive, or the Chief
19 Administrative Officer of the County if authorized by the County Executive of the County,
20 subject to certain guidelines and standards, to determine the time and method for the sale of such
21 refunding bonds, the form or forms thereof and other details with respect to the sale of such
22 refunding bonds; providing for the form of such refunding bonds; pledging the full faith and
23 credit of the County to the payment of such refunding bonds and the interest on such refunding
24 bonds, when due; providing for the levy and collection of all taxes, charges and assessments
25 necessary for the payment of the principal of and interest on such refunding bonds when due;
26 showing compliance with the limitations on the power of the County to incur indebtedness;
27 covenanting that the proceeds of such refunding bonds, or any moneys which may be deemed to
28 be proceeds, will not be used in a manner to cause such bonds to be arbitrage bonds and
29 covenanting on other matters relating to the tax exempt status of interest on such refunding
30 bonds; providing for the issuance of such refunding bonds in registered form, including central
31 depository and book-entry arrangements; generally providing for the consolidation,

1 authorization, issuance, sale and delivery of general obligation refunding bonds of the County
 2 and matters generally related thereto; and providing for compliance with Securities and
 3 Exchange Commission Rule 15c2-12.

4 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,
 5 Maryland, that the issuance, sale and delivery of general obligation bonds with serial maturities,
 6 including mandatory sinking fund installments in lieu of serial maturities (the "Bonds") of Prince
 7 George's County, Maryland (the "County"), in an aggregate principal amount not exceeding
 8 Eighty-seven Million Eight Hundred Seventy-four Thousand Dollars (\$87,874,000) is hereby
 9 authorized in order to finance costs of the capital projects (the "Authorized Capital Projects")
 10 listed in the table set forth in Attachment 1, attached to and made a part of this Act (the "Table of
 11 Projects") that have been authorized by the bond enabling acts set forth in the Table of Projects
 12 or by this Act. Each Authorized Capital Project is described in the Capital Budget of the County
 13 for the fiscal year ending June 30, 2000 (the "Capital Budget") under the heading set forth in the
 14 Table of Projects and has the identification number set forth in the Table of Projects. The
 15 descriptions of the Authorized Capital Projects contained in the Capital Budget are incorporated
 16 herein by reference as if set forth fully herein. The principal amount of Bonds authorized by this
 17 Act to finance costs of each Authorized Capital Project shall be the respective amount set forth in
 18 the columns in the Table of Projects marked "Authorized Principal Amount of Bonds". Each
 19 such principal amount of Bonds is hereby determined to be sufficient to complete at least a
 20 usable portion of the Authorized Capital Projects in respect of which such principal amount has
 21 been authorized. The probable useful lives of the Authorized Capital Projects are set forth in the
 22 Table of Projects. The Bonds shall be made payable within the average of the probable useful
 23 lives of the Authorized Capital Projects, which is twenty-one and three tenths (21.3) years, or, in
 24 the event the Bonds are consolidated with other bonds of the County pursuant to Section 3 of this
 25 Act, within the average of the probable useful lives of the capital projects financed with the
 26 proceeds of such consolidated issue of bonds (the "Consolidated Authorized Capital Projects").
 27 All Authorized Capital Projects have been identified and included in bond enabling acts ("Bond
 28 Enabling Acts") and have been approved by referendum to the extent required by applicable law.
 29 The Bonds are specifically exempted from the provisions of Sections 10 and 11 of Article 31 of
 30 the Annotated Code of Maryland, as amended, replaced or recodified from time to time. The
 31 powers granted under this Act are additional and cumulative and the bonds authorized by this

1 Act may be issued, notwithstanding that other bond acts or laws may provide for the same or
 2 similar purposes. This Act does not modify or repeal any prior acts granting bond issuing
 3 authority for the same or similar purposes.

4 SECTION 2. BE IT FURTHER ENACTED that the attached Table of Projects lists the
 5 Authorized Capital Projects that are to be financed in whole or in part with the proceeds of the
 6 Bonds, the currently estimated cost of each Authorized Capital Project or a usable portion
 7 thereof (the "Estimated Cost"), the portion of the Estimated Cost of each Authorized Capital
 8 Project to be financed hereunder (the "Bond Financed Portion"), the source or sources of funds to
 9 finance the balance of the Estimated Cost of each Authorized Capital Project (the "Other
 10 Funding Sources") and the probable useful life of each Authorized Capital Project.

11 It is hereby recognized and acknowledged that the information regarding the Estimated
 12 Cost, Bond Financed Portion and Other Funding Sources for each Authorized Capital Project set
 13 forth in the Table of Projects is derived from information and estimates referenced in the Capital
 14 Budget and the Capital Improvement Program of the County for fiscal years 2000 through 2003,
 15 inclusive (the "Capital Improvement Program"), and is necessarily subject to change because of
 16 corresponding changes in construction and other costs, project time schedules, availability of
 17 Other Funding Sources and other circumstances not now known or anticipated. It is the purpose
 18 and intent of this Act to authorize the borrowing of money to finance the Authorized Capital
 19 Projects as such projects are referenced in the Capital Budget and Capital Improvement Program
 20 and in any amended or subsequent capital budget or capital improvement program. To
 21 implement the intent and purpose of this Act in the most expeditious manner, the County
 22 Executive of the County (the "County Executive") by his or her order or, if so provided by order
 23 of the County Executive, the Chief Administrative Officer of the County (the "Chief
 24 Administrative Officer"), by his or her order, may revise the amounts set forth in the Table of
 25 Projects representing the Estimated Cost, Bond Financed Portion and Other Funding Sources for
 26 any Authorized Capital Project to be consistent with the information set forth in regard to such
 27 project in any amended or subsequent capital budget or capital improvement program. In the
 28 event that the Bond Financed Portion for an Authorized Capital Project is less than the amount
 29 appropriated for such project in the Capital Budget or any amended or subsequent capital budget
 30 and the entire principal amount of bonds issued for the Consolidated Authorized Capital Projects
 31 is not required for such projects, the County Executive by his or her order or, if so provided by

1 order of the County Executive, the Chief Administrative Officer by his or her order, may revise
 2 the Table of Projects to increase the Bond Financed Portion of such Authorized Capital Project
 3 to an amount not to exceed the appropriated amount for such project and, correspondingly, may
 4 reduce the bond financed portion of such other Consolidated Authorized Capital Projects and
 5 make other appropriate adjustments. Nothing contained in this Act shall be deemed to preclude
 6 the County Council by resolution from effecting such a revision in the Table of Projects. The
 7 authority granted in this Act to revise the Table of Projects shall not be construed to permit an
 8 increase in the aggregate principal amount of Bonds to be issued pursuant to this Act or to effect
 9 results inconsistent with the Charter of Prince George's County, Maryland, as amended, modified
 10 or recodified from time to time (the "County Charter") or other applicable laws; accordingly, any
 11 such revision to the Table of Projects shall evidence that (i) the Bond Financed Portion of each
 12 Authorized Capital Project is sufficient to complete at least a usable portion of such project, (ii)
 13 the amount of all bonds authorized to be issued for such Authorized Capital Projects, including
 14 the revised Bond Financed Portion, does not exceed the amount of bonds authorized by the
 15 respective Bond Enabling Acts for such projects, and (iii) the Bonds are payable within the
 16 average probable useful life of the Authorized Capital Projects or, if the Bonds are consolidated
 17 with other bonds of the County pursuant to Section 3 of this Act, within the average probable
 18 useful lives of the Consolidated Authorized Capital Projects.

19 SECTION 3. BE IT FURTHER ENACTED that the Bonds (or any portion of them) may
 20 be consolidated for sale and issued, may be sold and delivered as a single issue of Bonds or as
 21 two or more issues of Bonds, or may be consolidated with other bonds of the County, as
 22 authorized by Section 2C of Article 31 of the Annotated Code of Maryland, as amended,
 23 replaced, or recodified from time to time. Such bonds shall each be designated "Prince George's
 24 County, Maryland Consolidated Public Improvement Bonds, Series 19__," and, in the event such
 25 bonds are issued at more than one time, the County Executive or, if so provided by order of the
 26 County Executive, the Chief Administrative Officer, by order, may specify such additional
 27 designation as he shall deem appropriate. Moreover, the County Executive or, if so provided by
 28 order of the County Executive, the Chief Administrative Officer, is hereby authorized to provide
 29 such other or alternative designation as he deems necessary or convenient to indicate the year of
 30 issuance of the Consolidated Public Improvement Bonds.

31 SECTION 4. BE IT FURTHER ENACTED that, subject to and in accordance with the

1 provisions of this Act, the County Executive or, if so provided by order of the County Executive,
2 the Chief Administrative Officer, shall determine all matters relating to the advertisement, sale,
3 issuance, delivery and payment of the Bonds, including all matters relating to the forms, dates
4 and denominations of the Bonds, the principal maturities, the methods to be used in determining
5 interest payable on the Bonds, the provision of bond insurance on all or any portion of the
6 Bonds, and provisions for registration of the Bonds, for their redemption prior to stated maturity,
7 and for the use of facsimile signatures or seals, whether the Bonds are to be issued in book-entry
8 form and all matters incident to the issuance of the Bonds in book-entry form. The County
9 Executive or, if so provided by order of the County Executive, the Chief Administrative Officer,
10 shall provide for the form, numbering, term and authentication of the Bonds pursuant to Section
11 826 of the County Charter. The County Executive or, if so provided by order of the County
12 Executive, the Chief Administrative Officer, may provide that no Bonds shall be issued for
13 certain Authorized Capital Projects authorized by this Act to be financed by the Bonds and to
14 reduce the aggregate principal amount of Bonds to be issued accordingly, provided, however,
15 that the deletion of such Authorized Capital Projects shall not cause the Bonds to be payable
16 beyond the average of the probable useful lives of the remaining Authorized Capital Projects.
17 The County Executive or, if so provided by order of the County Executive, the Chief
18 Administrative Officer, may provide for a reduction in the aggregate principal amount of Bonds
19 to be issued consistent with a determination of the minimum bond denomination size based on
20 municipal security market practices regarding denomination size, and for a corresponding
21 reduction in the principal amount of Bonds issued to finance the cost of any Authorized Capital
22 Project, provided, however, that the principal amount of Bonds issued for each such Authorized
23 Capital Project after such reduction shall be sufficient to complete at least a usable portion of
24 each such Authorized Capital Project. It is hereby recognized and acknowledged that, in order to
25 manage prudently the capital programs of the County, particularly in light of federal income tax
26 laws and regulations that impose penalties and other financial consequences for the failure to
27 expend the proceeds of tax-exempt bonds in a timely manner, the County Executive, pursuant to
28 Section 3 of this Act, may provide for the financing of the Bond Financed Portion of an
29 Authorized Capital Project by the issuance of Bonds at more than one time and from time to
30 time. Notwithstanding the provisions of Sections 2, 3 and 4 of this Act, no order of the County
31 Executive or Chief Administrative Officer permitted under this Act shall authorize or permit a

1 reduction in the principal amount of Bonds issued for an Authorized Capital Project below the
2 amount for which the County Council has authorized temporary borrowing from other County
3 funds.

4 The County Executive or, if so provided by order of the County Executive, the Chief
5 Administrative Officer, may provide by order for certain maturities of the Bonds to be subject to
6 prior redemption at the option of the County. If the County Executive or the Chief
7 Administrative Officer, as the case may be, so provides and the Bonds are issued with such
8 option, then in the event that the County determines to exercise such option for the purpose of
9 effecting certain cost savings by refinancing a portion of the indebtedness evidenced by the
10 Bonds through the issuance and sale of refunding bonds, it is the intent of the County that such
11 refunding bonds be issued under the Enabling Acts referred to in this Act and that such refunding
12 bonds, if issued, shall constitute a refunding of indebtedness authorized by this Act and shall not
13 constitute additional indebtedness under such authority or under any other authority. The
14 aggregate principal amount of Bonds authorized to be issued hereunder may be increased by a
15 supplemental ordinance.

16 SECTION 5. BE IT FURTHER ENACTED that the Bonds shall be sold at public sale at,
17 above or below par value, by bids on sealed proposals to the bidder or bidders therefor for cash
18 whose bid or bids are determined to be for the best interest of the County, as provided in the
19 Notice of Sale for the Bonds, after having given public notice by advertisement. Such
20 advertisement, or a summary thereof, shall be published once in each of two consecutive weeks
21 next preceding the date of sale of the Bonds in one or more newspapers having a general
22 circulation in the County. The first of these publications shall be at least ten (10) days preceding
23 the date of sale of the Bonds. Such advertisement, or a summary thereof, may also be published
24 in "The Bond Buyer", a financial journal published in the City of New York and in such other
25 publications as the Director of Finance may determine to be in the best interest of the County.
26 The Bonds offered for sale at such public sale shall be awarded by the County Executive, or in
27 the event of the temporary absence or disability of the County Executive, by the Chief
28 Administrative Officer of the County pursuant to Section 410 of the County Charter. Authority
29 is hereby expressly delegated to the County Executive, or in his or her absence, to the Chief
30 Administrative Officer, to fix the date and the time of the sale of the Bonds. The sale of the
31 Bonds shall be held in a County Executive Conference Room in the County Administration

1 Building in Upper Marlboro, Maryland, or in such other place as may be designated by the
2 County Executive in the Notice of Sale for the Bonds.

3 SECTION 6. BE IT FURTHER ENACTED that there may be printed on each of the Bonds
4 the text of the approving legal opinion of Bond Counsel with respect to such Bonds. Any such
5 printed text shall be certified to be a correct copy of said opinion by the manual or facsimile
6 signature of the County Executive.

7 The Bonds shall contain similar provisions and be in substantially the form set forth in
8 Attachment 2, attached hereto and made a part hereof, and Bonds issued substantially in
9 accordance with said form, with appropriate insertions or deletions as indicated, when properly
10 executed and authenticated as required by this Section shall be deemed to constitute
11 unconditional general obligations of the County, to the payment of which, in accordance with the
12 terms thereof, its full faith and credit are pledged, and all the covenants and conditions contained
13 in the Bonds shall be deemed to be binding upon the County. Authority is hereby conferred on
14 the County Executive or, if so provided by order of the County Executive, the Chief
15 Administrative Officer, to complete, delete or modify the blanks in the respective bond forms
16 with necessary information, to insert applicable paragraphs as indicated or needed and to make
17 such additions, deletions and substitutions in the respective bond forms, not inconsistent with
18 this Act or the County Charter, as may be necessary or desirable for the sale of the Bonds,
19 including (without limitation) such additions, deletions and substitutions as may be necessary or
20 desirable in connection with the establishment or discontinuance of a book-entry registration
21 system for the Bonds.

22 SECTION 7. BE IT FURTHER ENACTED that immediately after the sale of the Bonds,
23 the interest rate or rates payable on the Bonds shall be fixed by an order of the County Executive
24 (the authority to fix such rates being hereby expressly delegated to said County Executive) or, in
25 his or her absence, by an order of the Chief Administrative Officer acting pursuant to Section
26 410 of the County Charter, in accordance with the respective terms and conditions of the sale of
27 the Bonds.

28 SECTION 8. BE IT FURTHER ENACTED that the official Notice of Sale and Bid for the
29 Bonds shall be substantially in the form set forth in Attachment 3 attached hereto and made a
30 part hereof, with such insertions or deletions as the County Executive or, if so provided by order
31 of the County Executive, the Chief Administrative Officer, may determine to be desirable due to

1 financial or market conditions or as otherwise permitted or required by this Act, including but
 2 not limited to changes appropriate in the event that the Bonds are to be registered in book-entry
 3 format.

4 SECTION 9. BE IT FURTHER ENACTED that the County Executive or, if so provided
 5 by order of the County Executive, the Chief Administrative Officer, may authorize on behalf of
 6 the County the delivery of a Preliminary Official Statement and a final Official Statement in
 7 connection with the issuance and sale of the Bonds.

8 SECTION 10. BE IT FURTHER ENACTED that the County Council hereby determines
 9 that the Bonds are at present within the debt limit imposed by Section 5(P) of Article 25A of the
 10 Annotated Code of Maryland (1998 Replacement Volume), as shown below:

22 SECTION 11. BE IT FURTHER ENACTED that the proceeds of the sale of the Bonds,
 23 including any premium and accrued interest received therefor, shall be paid directly to the
 24 Director of Finance of the County, who shall deposit the same in the proper accounts of the
 25 County. The cost of marketing the Bonds shall be the pro rata part of the cost of advertising,
 26 printing, legal services and other related expenditures (including, without limitation, any bond
 27 insurance premiums payable by the County), as may be determined by apportioning the
 28 aggregate amount of the cost of such advertising, printing, legal services and other related
 29 expenditures among the issue of Bonds and the issues of bonds authorized by other Acts or
 30 Ordinances and consolidated for sale with the issue of the Bonds, in the proportion to each issue
 31 which the amount for which each issue may be sold shall bear to the total amount received for all

1 of the issues so consolidated for sale. Such costs of issuance shall be allocated to the Authorized
 2 Capital Projects financed by the Bonds and shall be charged to the appropriate debt service
 3 accounts of the County by the Director of Finance. There shall be deducted from the total gross
 4 proceeds received for the Bonds any amount received on account of accrued interest and
 5 premium on such Bonds, which amounts shall be set apart by the Director of Finance in separate
 6 accounts and applied to the first interest payment on the Bonds; provided that, if so determined
 7 by the County Executive, or if so provided by order of the County Executive, by the Chief
 8 Administrative Officer, any premium on such Bonds may be applied to other purposes including
 9 (without limitation) payment of the costs of issuance. The balance of the proceeds of the sale of
 10 the Bonds shall be expended by the County for costs of the Authorized Capital Projects for
 11 which Bonds have been issued in accordance with this Act and the provisions of the respective
 12 enabling laws authorizing such Authorized Capital Projects. If the principal amount of Bonds
 13 issued for any Authorized Capital Project exceeds the amount needed to finance such Authorized
 14 Capital Project, the excess shall be applied to any other Authorized Capital Project of the same
 15 generic class or if no such Authorized Capital Project requires additional funds, to any other
 16 capital project permitted by the laws of the State of Maryland and of the County and by the
 17 County Charter.

18 Unless otherwise provided by act or resolution of the County Council or by order of the
 19 County Executive pursuant to Section 14 of this Act, earnings derived from the investment of the
 20 proceeds of the Bonds may be treated as general revenues of the County and applied to general
 21 County purposes and such use of investment proceeds is hereby acknowledged and authorized.

22 SECTION 12. BE IT FURTHER ENACTED that, for the purpose of paying the interest on
 23 and redeeming and paying the Bonds, as they respectively mature, the County shall include in
 24 the levy in each and every fiscal year during which any of the Bonds are outstanding ad valorem
 25 taxes upon all the legally assessable property within the corporate limits of the County in rate
 26 and amount sufficient to provide for the payment, when due, of the interest on the Bonds payable
 27 during such fiscal year and the principal of all of the Bonds due in each such fiscal year; and in
 28 the event the proceeds from taxes so levied in any such fiscal year shall prove inadequate for
 29 such purposes, additional taxes shall be levied, to the extent authorized by law, in succeeding
 30 fiscal years to make up such deficiency. The County may apply to the payment of the principal
 31 of and interest on the Bonds any funds received by it from the State of Maryland, the United

1 States of America, or any agency or instrumentality thereof, or from any other source, if such
 2 funds are granted for the purpose of assisting the County in obtaining public facilities of the class
 3 or classes of public facilities for which the Bonds, or the respective portions of the Bonds, are
 4 authorized or may be otherwise lawfully applied to such payment; to the extent that any such
 5 funds are applied to such purposes in any fiscal year as provided herein, the taxes hereby
 6 required to be levied shall be reduced proportionately.

7 The full faith and credit of the County and the taxing power of the County are hereby
 8 irrevocably pledged both to the punctual payment of the maturing principal of and interest on the
 9 Bonds as and when such principal and interest respectively become due, and to the levy and
 10 collection of the taxes hereinabove prescribed as and when such taxes become necessary in order
 11 to provide sufficient funds to meet the debt service requirement of the Bonds. The County
 12 hereby solemnly covenants with each of the registered owners of any of the Bonds to take all
 13 action as may be appropriate from time to time during the period that any of the Bonds remain
 14 outstanding and unpaid to provide the funds necessary to make the principal and interest
 15 payments on the Bonds. The debt service requirements of the Bonds shall have a first and prior
 16 claim on all moneys of the General Fund of the County on a parity with the claim for moneys
 17 required for payment of debt service on all other County general obligation indebtedness whether
 18 issued prior to or after the issuance of the Bonds; it is recognized, however, that some
 19 outstanding general obligation bonds of the County constitute a pledge of the unlimited taxing
 20 power of the County. The County further covenants and agrees with each of the registered
 21 owners of any of the Bonds to levy and collect the taxes hereinabove prescribed.

22 SECTION 13. BE IT FURTHER ENACTED that in the event any official of the County
 23 whose signature shall appear on any Bonds or on other instruments or documents pertaining
 24 thereto, shall cease to be such official prior to the delivery of the Bonds or other instruments or
 25 documents, or in the event that any official shall take office subsequent to the sale of the Bonds,
 26 his or her signature shall nevertheless be valid, sufficient and binding for the purposes herein
 27 intended.

28 SECTION 14. BE IT FURTHER ENACTED that the County Executive and the Chief
 29 Administrative Officer shall be the officers of the County responsible for the issuance of any
 30 Bonds within the meaning of the "arbitrage regulations" (defined below).

31 The County Executive or, if so provided by order of the County Executive, the Chief

1 Administrative Officer, and the Director of Finance shall be the officers of the County
2 responsible for the execution and delivery (on the date of issuance of the Bonds) of a certificate
3 of the County (the "Tax and Section 148 Certificate") which complies with the requirements of
4 Section 148 of the Internal Revenue Code of 1986, as amended ("Section 148"), and the
5 applicable regulations thereunder (the "arbitrage regulations"), and such officials are hereby
6 directed to execute the Tax and Section 148 Certificate and to deliver the same to bond counsel
7 on the date of the issuance of the Bonds.

8 The County shall set forth in the Tax and Section 148 Certificate its reasonable
9 expectations as to relevant facts, estimates and circumstances relating to the use of the proceeds
10 of the Bonds, or of any moneys, securities or other obligations on deposit to the credit of any
11 account of the County which may be deemed to be proceeds of the Bonds pursuant to Section
12 148 or the arbitrage regulations (collectively, "Bond Proceeds"). The County covenants that the
13 facts, estimates and circumstances set forth in the Tax and Section 148 Certificate will be based
14 on the County's reasonable expectations on the date of issuance of the Bonds and will be, to the
15 best of the certifying officials' knowledge, true and correct, as of that date. The County shall
16 also set forth in the Tax and Section 148 Certificate any elections provided for or permitted
17 under the provisions of the Internal Revenue Code of 1986, as amended, that the officials
18 executing the Tax and Section 148 Certificate deem advisable.

19 In the event that Bonds are issued pursuant to this Act with the expectation that interest on
20 such Bonds will be excludable from gross income for federal income tax purposes, the County
21 covenants with each of the registered owners of any of the Bonds that it will not make, or (to the
22 extent that it exercises control or direction) permit to be made, any use of the Bond Proceeds
23 which would cause the Bonds to be "arbitrage bonds" within the meaning of Section 148 and the
24 arbitrage regulations. The County further solemnly covenants that it will comply with Section
25 148 and the regulations thereunder which are applicable to the Bonds on the date of issuance
26 thereof and which may subsequently lawfully be made applicable thereto as long as the Bonds
27 remain outstanding and unpaid. The County Executive, the Chief Administrative Officer and the
28 Director of Finance of the County are hereby authorized and directed to prepare or cause to be
29 prepared and to execute, respectively, any certification, opinion or other document, including
30 (without limitation) the Tax and Section 148 Certificate, which may be required to assure that the
31 Bonds will not be deemed to be "arbitrage bonds" within the meaning of Section 148 and the

1 regulations thereunder.

2 In the event that Bonds are issued pursuant to this Act with the expectation that interest on
3 such Bonds will be excludable from gross income for federal income tax purposes, the County
4 Executive may make such covenants or agreements in connection with the issuance of such
5 Bonds as he or she shall deem advisable in order to assure the registered owners of such Bonds
6 that interest thereon shall be and remain excludable from gross income for federal income tax
7 purposes, and such covenants or agreements shall be binding on the County so long as the
8 observance by the County of any such covenants or agreements is necessary in connection with
9 the maintenance of the exclusion of the interest on such Bonds from gross income for federal
10 income tax purposes. The foregoing covenants and agreements may include such covenants or
11 agreements on behalf of the County regarding compliance with the provisions of the Internal
12 Revenue Code of 1986, as amended, as the County Executive shall deem advisable in order to
13 assure the registered owners of such Bonds that the interest thereon shall be and remain
14 excludable from gross income for federal income tax purposes, including (without limitation)
15 covenants or agreements relating to the investment of Bond Proceeds, the payment of certain
16 earnings resulting from such investment to the United States (or certain payments in lieu thereof
17 as provided in the Internal Revenue Code of 1986, as amended), limitations on the times within
18 which, and the purpose for which, Bond Proceeds may be expended, or the use of specified
19 procedures for accounting for and segregating Bond Proceeds. Any covenant or agreement made
20 by the County Executive pursuant to this paragraph shall be set forth in or authorized by an order
21 executed by the County Executive.

22 SECTION 15. BE IT FURTHER ENACTED that the County Executive or, if so provided
23 by order of the County Executive, the Chief Administrative Officer, is hereby authorized to
24 select and appoint a bank or other financial institution to act as paying agent for the payment of
25 the principal and redemption price, if any, of and interest on the Bonds and to act as registrar for
26 the Bonds. The selection of the paying agent and bond registrar shall be accomplished in
27 accordance with applicable provisions of law. In the event that the Bonds are issued in book-
28 entry form, the County Executive may determine that a Bond Registrar need not be designated or
29 that the County shall act as bond registrar and paying agent.

30 SECTION 16. BE IT FURTHER ENACTED that the powers granted by this Act are
31 additional and cumulative and the Bonds authorized by this Act may be issued, notwithstanding

1 that other bond acts or laws may provide for the issuance of other bonds or the borrowing of
 2 money for the same or similar purposes on the same or other terms and conditions. This Act
 3 shall be liberally construed to effectuate its purposes, namely, to authorize the borrowing of
 4 money and the incurring of indebtedness to finance the Authorized Capital Projects set forth in
 5 this Act. Provisions of this Act shall be deemed met and satisfied if there is substantial
 6 compliance with such provisions. This Act is not intended to provide or imply that this Act or
 7 any prior act not containing a similar provision precludes the County from exercising any power
 8 or prerogative provided by this Act or any other law whether exercised solely pursuant to such
 9 other law or in conjunction with the powers provided by this Act so that, without limiting the
 10 generality of this Section, the County may exercise the power to issue (i) bond anticipation notes
 11 (in anticipation of the issuance of bonds pursuant to this Act or otherwise) and grant anticipation
 12 notes pursuant to Section 12 of Article 31 of the Annotated Code of Maryland, as amended,
 13 replaced, or recodified from time to time, and (ii) bonds (or any related bond anticipation or
 14 other notes) authorized by Sections 14-201 to 14-214, inclusive, of Article 41 of the Annotated
 15 Code of Maryland, as amended, replaced, or recodified from time to time, and in exercising such
 16 powers, the County may sell such notes or bonds at private (negotiated) sale as authorized by
 17 these or any other applicable laws.

18 SECTION 17. BE IT FURTHER ENACTED that in order to avoid the issuance of a
 19 greater amount of Bonds for the Authorized Capital Projects listed in the Table of Projects than
 20 is needed therefor, and in order to permit the construction of such projects to proceed prior to the
 21 issuance of Bonds and at the same time afford the County maximum flexibility in selecting the
 22 most advantageous times for such issuance, the County may provide needed capital funds by the
 23 issue and sale of its bond anticipation notes (the "Notes") pursuant to the authority of Section 12
 24 of Article 31 of the Annotated Code of Maryland, as amended, replaced or recodified from time
 25 to time (the "Bond Anticipation Note Act").

26 (1) The maximum principal amount of Notes issued pursuant to this Section which
 27 may be outstanding at any time shall be Eighty-seven Million Eight Hundred Seventy-four
 28 Thousand Dollars (\$87,874,000) unless and until otherwise provided by the County Council by
 29 act. The Notes may be paid at or prior to maturity from the proceeds of the issuance and sale of
 30 the Bonds in anticipation of which the Notes were issued or from the proceeds of refunding
 31 Notes. Except as otherwise provided herein, in the event of such an advance refunding, the

1 proceeds of such refunding Bonds or Notes shall be held in escrow, to the extent and in the
 2 amount necessary to refund the outstanding series of Notes, for the benefit of the holders of the
 3 outstanding series of Notes. Such refunding Notes, if issued, will constitute a reissuance of the
 4 Notes authorized by this Act and shall not constitute additional indebtedness under such
 5 authorization.

6 (2) All or any part of the Notes may be issued in series as funds are required, as
 7 determined by the County Executive.

8 (3) None of the Notes shall be sold at less than the par value thereof except
 9 Commercial Paper Notes (hereinafter defined) as hereinafter provided, nor shall any such Notes
 10 bear interest at a rate in excess of the maximum interest rate, if any, specified by the County
 11 Council by Public Local Law to be payable on obligations of Prince George's County, Maryland.

12 (4) With respect to any Notes issued, the County hereby covenants and agrees with
 13 the holder or holders thereof to issue, upon its full faith and credit, the Bonds in anticipation of
 14 the sale of which the Notes are issued when, and as soon as, the reason for deferring the issuance
 15 thereof no longer exists and to pay the principal of and interest on (to the extent such interest has
 16 not been capitalized, or otherwise paid, by appropriations from current revenues) such Notes
 17 from the proceeds of such Bonds. This covenant shall be binding upon the County
 18 notwithstanding any limitation set forth in this Act, including (without limitation) any limitation
 19 with respect to the interest rate or rates that the Bonds may bear. If the County shall be unable,
 20 for reasons beyond its control, to issue and sell its Bonds as described above, or if the proceeds
 21 from the sale of such Bonds shall be insufficient to pay the principal of and interest on any Notes
 22 issued, then the revenues from taxes and other sources intended for application to debt service on
 23 such Bonds shall be applied to the payment of the interest on and principal of the Notes. The
 24 foregoing provisions shall not be construed so as to prohibit the County from paying the
 25 principal or redemption price of and interest on any Note issued hereunder from the proceeds of
 26 the sale of any other Note issued hereunder, or from any other funds legally available for that
 27 purpose. If the County shall be unable, for reasons beyond its control, to issue and sell its Bonds,
 28 or if the proceeds from the sale of such Bonds shall be insufficient to pay the principal of or
 29 interest on any Notes issued, then the County shall include in the levy in each and every fiscal
 30 year during which any of the Notes are outstanding ad valorem taxes upon all the legally
 31 assessable property within the corporate limits of the County in rate and amount sufficient to

1 provide for the payment, when due, of the interest on the Notes payable during such fiscal year
 2 and the principal of all of the Notes due in each such fiscal year; and in the event the proceeds
 3 from taxes so levied in any such fiscal year shall prove inadequate for such purposes, additional
 4 taxes shall be levied, to the extent authorized by law, in succeeding fiscal years to make up such
 5 deficiency. The County may apply to the payment of the principal of and interest on the Notes
 6 any funds received by it from the State of Maryland, the United States of America, or any agency
 7 or instrumentality thereof, or from any other source, if such funds are granted for the purposes of
 8 assisting the County in obtaining public facilities of the class or classes of public facilities for
 9 which the Notes, or the respective portions of the Notes, are authorized or may be otherwise
 10 lawfully applied to such payment; to the extent that any such funds are applied to such purposes
 11 in any fiscal year as provided herein, the taxes hereby required to be levied shall be reduced
 12 proportionately.

13 The full faith and credit of the County and the taxing power of the County are hereby
 14 irrevocably pledged both to the punctual payment of the maturing principal of and interest on
 15 the Notes as and when such principal and interest respectively become due, and to the levy and
 16 collection of the taxes hereinabove prescribed as and when such taxes become necessary in order
 17 to provide sufficient funds to meet the debt service requirements of the Notes. The County
 18 hereby solemnly covenants with each of the owners of any of the Notes to take all action as may
 19 be appropriate from time to time during the period that any of the Notes remain outstanding and
 20 unpaid to provide the funds necessary to make the principal and interest payments on the Notes.
 21 The debt service requirements of the Notes shall have a first and prior claim on all moneys of
 22 the General Fund of the County on a parity with the claim for moneys required for payment of
 23 debt service on all other County general obligation indebtedness whether issued prior to or after
 24 the issuance of the Notes; it is recognized, however, that some outstanding general obligation
 25 bonds of the County constitute a pledge of the unlimited taxing power of the County. The
 26 County further covenants and agrees with each of the owners of any of the Notes to levy and
 27 collect the taxes hereinabove prescribed.

28 (5) In the event that any Notes (the "Outstanding Notes") issued hereunder are
 29 outstanding on the date that the Bonds in anticipation of which such Notes are issued are
 30 delivered in exchange for the purchase price thereof (the "Delivery Date"), the Director of
 31 Finance shall deposit with the paying agent for the Notes, or a trustee or escrow agent, on the

1 Delivery Date (i) cash in an amount equal to the principal of the Outstanding Notes and/or (ii)
 2 direct obligations of, or obligations the payment of which is unconditionally guaranteed by, the
 3 United States of America, the principal of and interest on which will be sufficient without
 4 reinvestment to pay in a timely manner the principal of the Outstanding Notes when due whether
 5 at maturity or upon prior redemption. Such paying agent or trustee or escrow agent is hereby
 6 irrevocably directed to apply such cash or the proceeds of such obligations to the payment of the
 7 principal of the Outstanding Notes when due whether at maturity or upon prior redemption. The
 8 County may provide such cash or obligations from the proceeds of the sale of such Bonds or
 9 from any other funds legally available for such purpose. On the Delivery Date, the Director of
 10 Finance shall also deposit with the paying agent for the Outstanding Notes, or a trustee or escrow
 11 agent (i) cash in an amount equal to the interest on the Outstanding Notes and/or (ii) direct
 12 obligations of, or obligations the payment of which is unconditionally guaranteed by, the United
 13 States of America, the principal of and interest on which will be sufficient without reinvestment
 14 to pay in a timely manner interest on the Outstanding Notes when due whether at maturity, upon
 15 a regularly scheduled payment date or upon prior redemption. The County may provide such
 16 cash obligations from the proceeds of the sale of Bonds available for that purpose or from any
 17 other funds legally available for such purpose. Notwithstanding the foregoing, if the Delivery
 18 Date and the date on which the Outstanding Notes mature or are subject to redemption are in
 19 different fiscal years, and moneys for the payment of the interest on the Outstanding Notes have
 20 not been finally appropriated in the fiscal year in which the Bonds are delivered, and if the
 21 Delivery Date is after the date on which the budget for the succeeding fiscal year has been
 22 submitted to the County Council and provision for the payment of the interest on such
 23 Outstanding Notes has been made in such budget, in lieu of the deposit of such cash or
 24 obligations for the payment of interest on the Outstanding Notes, the County Executive, the
 25 Director of Finance and the Chief Administrative Officer may deliver a certificate on the
 26 Delivery Date of the Bonds stating that funds sufficient to pay the interest on the Outstanding
 27 Notes have been included in the budget for the next succeeding fiscal year (it being provided by
 28 the Bond Anticipation Note Act that the Notes shall be payable from the first proceeds of the sale
 29 of the Bonds, or from the tax or other revenue which the County shall have previously
 30 determined to apply to the payment of the Bonds and the interest thereon). Upon the deposit
 31 with the paying agent for the Outstanding Notes, or a trustee or escrow agent, of cash and/or

1 obligations sufficient to provide for the payment of the principal of and interest on such Notes
 2 when due, as described above, such Notes shall be deemed to be paid and no longer outstanding
 3 hereunder.

4 (6) With respect to the authorization, issuance, execution, sale, delivery and payment
 5 of and for any Notes, the County Executive or, if so provided by order of the County Executive,
 6 the Chief Administrative Officer, may determine, approve or authorize:

- 7 (i) the identification of any series of Notes;
- 8 (ii) the form of any Notes;
- 9 (iii) the denominations of the Notes;
- 10 (iv) the maturity of any Notes;
- 11 (v) the manner of execution and authentication of any Notes;
- 12 (vi) the rate or rates of interest of any Notes or the manner for determining the
 13 same;
- 14 (vii) the interest payment dates of any Notes;
- 15 (viii) the redemption provisions applicable to any Notes;
- 16 (ix) the manner of sale of any Notes, which may be by private (negotiated) sale
 17 or at public sale, and the procedures to be followed in connection with any such sale;
- 18 (x) the form and manner of execution and delivery of documents necessary or
 19 deemed appropriate in connection with the authorization, issuance, execution, sale, delivery and
 20 payment of and for any Notes; and
- 21 (xi) such other matters not inconsistent with the provisions of this Act as are
 22 necessary or deemed appropriate to accomplishing the issuance and sale of Notes hereunder.

23 (7) The Notes (or any portion of them) may be consolidated for sale and issued, sold
 24 and delivered as a single issue of Notes or as two or more issues of Notes, or may be
 25 consolidated with other notes or indebtedness of the County, as authorized by Section 2C of
 26 Article 31 of the Annotated Code of Maryland, as amended, replaced or recodified from time to
 27 time.

28 (8) References to "Bonds" in Section 14 of this Act shall be deemed to include Notes.

29 (9) The authority conferred on the County Executive in Section 15 of this Act in
 30 connection with the issuance of Bonds hereunder, with respect to the appointment of paying
 31 agents and a registrar, may also be exercised with respect to the issuance and sale of Notes

1 hereunder.

2 (10) References to "Bonds authorized by this Act" in Section 16 of this Act shall be
3 deemed to include Notes, unless the context clearly requires otherwise.

4 (11) Pursuant to the Bond Anticipation Note Act, the County is hereby authorized to
5 issue the aforementioned Notes as notes in the nature of commercial paper and to establish a
6 commercial paper program. Accordingly, the County is hereby authorized to issue two or more
7 separate and distinct series of its Notes, which may include (1) a series of its Notes in the nature
8 of tax exempt commercial paper (the "Commercial Paper Notes") and (2) a series of its Notes in
9 connection with a liquidity facility, such as a revolving loan agreement, or a series of its Notes in
10 connection with a credit facility, such as a letter of credit and related agreements (collectively,
11 the "Revolving Loan Notes") (the Commercial Paper Notes and the Revolving Loan Notes being
12 collectively referred to herein as the "Program Notes"). The word "Notes," as used in this Act,
13 includes Program Notes, and it is intended that the provisions of this Act applying to Notes shall
14 include Program Notes unless the context clearly requires a contrary meaning.

15 For the purposes of this Act, the term "principal amount," when used with respect to the
16 Program Notes, shall mean (i) in the case of Commercial Paper Notes, the face amount of any
17 such Commercial Paper Note, less any original issue discount on such Commercial Paper Note,
18 and (ii) in the case of Revolving Loan Notes, the principal amount actually advanced under the
19 applicable liquidity facility or credit facility that is evidenced by any such Revolving Loan Note.
20 Accordingly, it is contemplated by this Act that the aggregate face amount of the Program Notes
21 that may be outstanding from time to time hereunder, together with other Notes issued hereunder
22 and outstanding from time to time, may exceed the aggregate principal amount of Notes
23 authorized to be outstanding hereunder at any one time.

24 Without limiting the generality of other provisions of this Act, the County Executive or, if
25 so provided by order of the County Executive, the Chief Administrative Officer, may determine,
26 approve or authorize:

27 (i) procedures to facilitate the prompt determination and approval of matters in
28 connection with the authorization, issuance, execution, sale, delivery and payment of and for
29 Program Notes;

30 (ii) the form and manner of execution and delivery of documents necessary or
31 deemed appropriate in connection with the authorization, issuance, execution, sale, delivery and

1 payment of and for Program Notes;

2 (iii) the selection of any trustee, issuing agent, payment agent, commercial paper
3 dealer, credit or liquidity facility provider or other provider of financial or related services
4 necessary or deemed appropriate to the authorization, issuance, execution, sale, delivery and
5 payment of and for Program Notes; and

6 (iv) such other matters not inconsistent with this Act necessary or deemed
7 appropriate to accomplishing the authorization, issuance, execution, sale, delivery and payment
8 of and for Program Notes.

9 SECTION 18. BE IT FURTHER ENACTED that it is hereby found and determined as
10 follows: (i) it is in the best interest of the County to be able to implement a flexible approach to
11 borrowing (that is, one which provides the ability to utilize variable rate demand obligations, tax
12 exempt commercial paper and short-term municipal obligations [collectively, "Variable Rate
13 Demand Obligations"]); (ii) there is an expanding market for Variable Rate Demand Obligations,
14 which have varying and flexible maturities or redemption features, tender or purchase dates and
15 bear interest at variable rates established by a remarketing agent on the basis of current market
16 conditions, or combinations of such maturities or redemption, tender or purchase dates and rates
17 and to access this market the County must establish procedures consistent with market practices
18 for Variable Rate Demand Obligations; and (iii) existing practices in the market for Variable
19 Rate Demand Obligations and existing requirements of nationally recognized rating agencies
20 require that there be available to the issuer of Variable Rate Demand Obligations a supporting
21 credit or liquidity facility, such as a letter of credit, line of credit or revolving loan agreement,
22 pursuant to which an alternate source of borrowing will be available during any period in which
23 such obligations cannot be remarketed or sold.

24 Notes or Bonds are hereby authorized to be issued as short-term or demand obligations or
25 commercial paper, defined above as Variable Rate Demand Obligations, including obligations
26 that are required to be purchased or redeemed prior to stated maturity dates, bear interest at
27 variable rates and mature on dates established from time to time by a remarketing agent on the
28 basis of current market conditions. If any Bonds or Notes issued in accordance with this Section
29 18 provide for the optional or mandatory redemption, tender or purchase thereof prior to stated
30 maturity dates, the form of Bond or Note (as the case may be) may provide, to the extent
31 permitted by law and determined by the County Executive or, if so provided by order of the

1 County Executive, the Chief Administrative Officer, that the full faith and credit and taxing
2 power of the County are pledged to the payment of the purchase or redemption price on the due
3 dates for such payments.

4 Without limiting the generality of other provisions of this Act, the County Executive or, if
5 so provided by order of the County Executive, the Chief Administrative Officer, may determine,
6 approve or authorize:

7 (i) procedures for the determination of the interest rates, the interest payment dates,
8 the maturities and any optional or mandatory redemption, tender or purchase dates of Bonds or
9 Notes described in this Section 18 in order to implement the financing authorized hereby;

10 (ii) the form and manner of execution and delivery of documents necessary or
11 deemed appropriate in connection with the authorization, issuance, execution, sale, delivery and
12 payment of and for Variable Rate Demand Obligations;

13 (iii) the selection of any trustee, issuing agent, paying agent, tender agent, credit or
14 liquidity facility provider or other provider of financial or related services necessary or deemed
15 appropriate to the authorization, issuance, execution, sale, delivery and payment of and for
16 Variable Rate Demand Obligations; and

17 (iv) such other matters not inconsistent with this Act necessary or deemed appropriate
18 to accomplishing the authorization, issuance, execution, sale, delivery and payment of and for
19 Variable Rate Demand Obligations.

20 SECTION 19. BE IT FURTHER ENACTED that Section 24 of Article 31 of the
21 Annotated Code of Maryland (1997 Replacement Volume and 1997 Supplement) (the
22 "Refunding Act") provides that refunding bonds may be issued by the County for certain public
23 purposes specified in the Refunding Act, including realizing savings to the County in the
24 aggregate cost of debt service on either a direct comparison or present value basis or debt
25 restructuring that in the aggregate effects such a savings in the cost of debt service. The County
26 Council of Prince George's County, Maryland, hereby finds and determines that the issuance of
27 refunding bonds pursuant to the terms and requirements of this Act, and particularly Section 23
28 of this Act, in order to refund all or a portion of the outstanding principal amount of the Bonds
29 will effectuate and accomplish the public purpose of realizing savings to the County in the
30 aggregate cost of debt service on either a direct comparison or a present value basis or of debt
31 restructuring that in the aggregate effects such a reduction in the cost of debt service.

1 SECTION 20. BE IT FURTHER ENACTED that, acting pursuant to the authority of the
2 Refunding Act and, as applicable, Article 25A of the Annotated Code of Maryland (1998
3 Replacement Volume) ("Article 25A"), the County Charter, this Act and certain other authority
4 pursuant to which the Bonds will be issued, the issuance and sale of bonds (the "Consolidated
5 Refunding Bonds") of Prince George's County, Maryland, which may be issued in series from
6 time to time as hereinafter provided, are hereby authorized in an aggregate principal amount not
7 to exceed 150% of the aggregate outstanding principal amount of the Bonds to be refunded
8 hereby (the "Refunded Bonds") in order to provide funds sufficient (a) to purchase direct
9 obligations of, or obligations the timely payment of the principal of and interest on which is
10 unconditionally guaranteed by, the United States of America ("Government Obligations"), the
11 principal of and interest on which will be sufficient without reinvestment, together with any
12 available cash, to pay in a timely manner all or any part of the principal of and redemption
13 premium, if any, and interest on the Refunded Bonds, and (b) to pay any and all other costs
14 permitted to be paid from the proceeds of such Consolidated Refunding Bonds under the
15 Refunding Act, including (without limitation) the costs of issuance of such Consolidated
16 Refunding Bonds (including without limitation any bond insurance premium payable by the
17 County) and applicable underwriting fees.

18 SECTION 21. BE IT FURTHER ENACTED that the Consolidated Refunding Bonds
19 hereby authorized may be sold for a price at, above, or below par, plus accrued interest to the
20 date of delivery. The Consolidated Refunding Bonds shall be sold at private (negotiated) sale,
21 and such procedure is hereby determined to be in the public interest. Notwithstanding the
22 foregoing, if the County Executive or, if so provided by order of the County Executive, the Chief
23 Administrative Officer, by order, subsequently determines that it is in the best interests of the
24 County to sell any or all of the Consolidated Refunding Bonds after first soliciting competitive
25 bids at public sale, then the County Executive or the Chief Administrative Officer, as the case
26 may be, may sell such Consolidated Refunding Bonds in such manner in accordance with such
27 procedures as he or she shall deem appropriate; provided, however, that such procedures shall be
28 substantially similar to the procedures for public sale with competitive bidding normally used by
29 the County in connection with the sale of its general obligation bonds. Consolidated Refunding
30 Bonds issued hereunder are hereby specifically exempted from the provisions of Sections 10 and
31 11 of Article 31 of the Annotated Code of Maryland (1997 Replacement Volume and 1997

1 Supplement).

2 SECTION 22. BE IT FURTHER ENACTED that Consolidated Refunding Bonds
3 authorized to be issued for the purposes specified above may be issued in series from time to
4 time. Each such series shall identify the public purpose for which it is issued, by the printing on
5 each bond of the words "Prince George's County, Maryland Consolidated Public Improvement
6 Bonds - 19__ Refunding Series". The County Executive or, if so provided by order of the
7 County Executive, the Chief Administrative Officer, by order, may incorporate such additional
8 designations in the name of the series as he or she deems necessary or convenient to distinguish
9 two or more series issued for the same purpose within the same calendar year.

10 SECTION 23. BE IT FURTHER ENACTED that the Consolidated Refunding Bonds shall
11 be issued as registered bonds without coupons in the denomination of Five Thousand Dollars
12 (\$5,000) or any integral multiple thereof within the limits of specified maturities with the
13 maximum denomination to be determined by the County Executive or, if so provided by order of
14 the County Executive, the Chief Administrative Officer, by order. The Consolidated Refunding
15 Bonds of each series shall be dated prior to or the date of the delivery of such series as
16 determined by the County Executive or, if so provided by order of the County Executive, the
17 Chief Administrative Officer. The Consolidated Refunding Bonds, when first issued, shall be
18 numbered from No. R-1 consecutively upward in the order of their maturities or such other
19 designation, as determined by the County Executive or, if so provided by Order of the County
20 Executive, the Chief Administrative Officer, but such numbering need not be continuously
21 consecutive; provided, however, that Consolidated Refunding Bonds issued after the original
22 issuance of the Consolidated Refunding Bonds may be numbered consecutively without regard
23 to their maturities at the discretion of the Refunding Bond Registrar (hereinafter defined) to
24 conform with standard registered bond registration practices. Registration books (the
25 "Refunding Bond Register") for the Consolidated Refunding Bonds shall be maintained by the
26 bond registrar to be selected and appointed by the County Executive of the County pursuant to
27 this Act (the "Refunding Bond Registrar").

28 The Consolidated Refunding Bonds of each series, or of successive series for the same
29 public purpose, shall mature and be payable in consecutive annual installments.

30 Pursuant to Section 26 of this Act, the County Executive or, if so provided by order of the
31 County Executive, the Chief Administrative Officer, by order, shall determine (a) the principal

1 amount and maturity of each series of Consolidated Refunding Bonds to be issued and (b) the
2 portions of each series of Refunded Bonds to be refunded with the proceeds of each series of
3 Consolidated Refunding Bonds; provided, however, that the issuance of any series of
4 Consolidated Refunding Bonds to refund all or any portion of one or more series of Refunded
5 Bonds will effectuate and accomplish the public purpose of realizing savings to the County in the
6 aggregate cost of debt service on either a direct comparison or a present value basis with respect
7 to the portion of any series of Refunded Bonds being refunded or debt restructuring that in the
8 aggregate effects such a reduction in the cost of debt service.

9 The series of Consolidated Refunding Bonds to be issued pursuant to the authority of this
10 Act shall be executed on behalf of the County by the manual or facsimile signature of the County
11 Executive and an impression of the seal of the County shall be imprinted thereon manually or by
12 facsimile, attested by the manual or facsimile signature of the Clerk of the Council. Each such
13 Consolidated Refunding Bond shall be authenticated by the manual signature of the County
14 Executive or Director of Finance of the County or an authorized officer of the Refunding Bond
15 Registrar. No Consolidated Refunding Bonds issued pursuant to this Act shall be valid for any
16 purpose or constitute an obligation of the County unless so authenticated. In case any official of
17 the County, whose signature shall appear on any such Consolidated Refunding Bonds, shall
18 cease to be such official prior to the delivery of such Consolidated Refunding Bonds, or in the
19 case that any such official shall take office subsequent to the date of issue of any such
20 Consolidated Refunding Bonds, his or her signature, in either event, shall nevertheless be valid
21 for the purposes herein intended.

22 There may be printed on the reverse side of each series of Consolidated Refunding Bonds
23 issued hereunder the text of the applicable approving legal opinion with respect thereto, and any
24 such text shall be duly certified by the manual or facsimile signature of the County Executive of
25 the County.

26 Each series of Consolidated Refunding Bonds shall be in the form set forth in Attachment 2
27 attached to and made a part of this Act with such changes in designation and purpose to reflect
28 that such Bonds are refunding bonds, and Consolidated Refunding Bonds issued substantially in
29 compliance with such form, with appropriate insertions as therein indicated, when properly
30 executed and authenticated as described above, shall be deemed to constitute unconditional
31 general obligations of the County, to the payment of which, in accordance with the terms thereof,

1 its full faith and credit are pledged, and all the covenants and conditions contained in such
2 Consolidated Refunding Bonds shall be deemed to be binding upon the County in accordance
3 therewith. Authority is hereby conferred on the County Executive or, if so provided by order of
4 the County Executive, the Chief Administrative Officer, to fill the blanks in such form with the
5 required information, to insert applicable paragraphs as indicated and to make such additions,
6 deletions and substitutions in such form, not inconsistent with this Act, as may be necessary or
7 desirable in the sale of any such series of Consolidated Refunding Bonds, including (without
8 limitation) such changes as may be necessary to permit the establishment of a central depository
9 or book-entry system with respect to such series of Consolidated Refunding Bonds.

10 SECTION 24. BE IT FURTHER ENACTED that, for the purpose of paying the interest
11 and redeeming and paying the Consolidated Refunding Bonds, as they respectively mature, the
12 County shall include in the levy in each and every fiscal year during which any of the
13 Consolidated Refunding Bonds are outstanding ad valorem taxes upon all the legally assessable
14 property within the corporate limits of the County in rate and amount sufficient to provide for the
15 payment, when due, of the interest on the Consolidated Refunding Bonds payable during such
16 fiscal year and the principal of all of the Consolidated Refunding Bonds due in each such fiscal
17 year; and in the event the proceeds from taxes so levied in any such fiscal year shall prove
18 inadequate for such purposes, additional taxes shall be levied, to the extent authorized by law, in
19 succeeding fiscal years to make up such deficiency. The County may apply to the payment of
20 the principal of and interest on the Consolidated Refunding Bonds any funds received by it from
21 the State of Maryland, the United States of America, or any agency or instrumentality of either,
22 or from any other source, if such funds are granted for the purpose of assisting the County in
23 obtaining public facilities of the class or classes of public facilities for which the Refunded
24 Bonds refunded with the proceeds of the Consolidated Refunding Bonds issued pursuant to this
25 Act, or the respective portions of such Refunded Bonds, are authorized or may otherwise be
26 lawfully applied to such payment; to the extent that any such funds are applied to such purposes
27 in any fiscal year as provided herein, the taxes hereby required to be levied shall be reduced
28 proportionately.

29 The full faith and credit of the County and the taxing power of the County are hereby
30 irrevocably pledged both to the punctual payment of the maturing principal of and interest on the
31 Consolidated Refunding Bonds as and when such principal and interest respectively become due,

and to the levy and collection of the taxes hereinabove prescribed as and when such taxes become necessary in order to provide sufficient funds to meet the debt service requirements of the Consolidated Refunding Bonds. The County hereby solemnly covenants with each of the holders of any of the Consolidated Refunding Bonds to take all action as may be appropriate from time to time during the period that any of the Consolidated Refunding Bonds remain outstanding and unpaid to provide the funds necessary to make the principal and interest payments on the Consolidated Refunding Bonds. The debt service requirements of the Consolidated Refunding Bonds shall have a first and prior claim on all moneys of the General Fund of the County on a parity with the claim for moneys required for payment of debt service on all other County general obligation indebtedness whether issued prior to or after the issuance of the Consolidated Refunding Bonds; it is recognized, however, that some outstanding general obligation indebtedness of the County constitute a pledge of the unlimited taxing power of the County. The County further covenants and agrees with each of the holders of any of the Consolidated Refunding Bonds to levy and collect the taxes hereinabove prescribed.

SECTION 25. BE IT FURTHER ENACTED that the County Council hereby determines that the Consolidated Refunding Bonds are at present within the debt limit imposed by Section 5(P) of Article 25A of the Annotated Code of Maryland (1998 Replacement Volume), as shown below:

SECTION 26. BE IT FURTHER ENACTED that, with respect to each series of Consolidated Refunding Bonds sold pursuant to this Act, authority is hereby conferred on the County Executive or, if so provided by order of the County Executive, the Chief Administrative Officer, to take the following actions and make the following commitments on behalf of the County:

(a) in the event any series of Consolidated Refunding Bonds is sold at private (negotiated) sale as authorized by this Act, to sell such series of Consolidated Refunding Bonds issued under this Act upon such terms as he or she deems favorable under the existing market conditions to a bank, investment banking firm or other financial institution that, in such official's judgment, offers to purchase such series of Consolidated Refunding Bonds on terms such official deems favorable to the County under the existing market conditions;

(b) in the event any series of Consolidated Refunding Bonds is sold at private (negotiated) sale as authorized by this Act, to approve, execute and deliver, as a binding and enforceable obligation of the County, an underwriting or purchase agreement for any series of Consolidated Refunding Bonds issued pursuant to this Act;

(c) after considering any recommendations of the financial advisor to the County and subject to the provisions of Section 23 of this Act, to fix and determine the date of any such series of Consolidated Refunding Bonds, the schedule of annual maturities of any such series, the amount of any such series, the amounts and particular Refunded Bonds of each series to be refunded with the proceeds of any such series of Consolidated Refunding Bonds, and the interest rate or rates to be paid by the County with respect to any such series, including, without limitation, the payment dates for the payment of interest with respect to each maturity of any such series and all matters relating to the provision of bond insurance, if any, on all or any portion of the Consolidated Refunding Bonds;

(d) to determine whether the principal of the Refunded Bonds shall be paid at maturity, at the earliest redemption date pertaining thereto, or at some later redemption date;

1 (e) in the event that the County Executive or the Chief Administrative Officer, as the
2 case may be, determines that it is in the best interests of the County to sell any such series of
3 Consolidated Refunding Bonds by soliciting competitive bids at public sale, to
4 determine the date, time and place when proposals for the purchase of any such series of
5 Consolidated Refunding Bonds will be received, to publish and otherwise distribute a suitable
6 notice of sale and provide for a summary thereof for advertisement of such Consolidated
7 Refunding Bonds and to award any series of Consolidated Refunding Bonds for which a legally
8 sufficient proposal has been received to the best bidder;

9 (f) to appoint a bank having trust powers, or a trust company, as Paying Agent for
10 any such series of Consolidated Refunding Bonds, notwithstanding the fact that such bank or
11 trust company may have neither its principal office nor any branch office within the County or
12 the State of Maryland, and if appropriate, to appoint a similarly qualified bank or trust company
13 as Alternate Paying Agent, such authority to include the power to agree with respect to the
14 compensation of such Paying Agent and Alternate Paying Agent for the services to be rendered
15 by them; to appoint one or more of such banks or trust companies as Refunding Bond Registrars;
16 and to select and approve the designation of a custodian for a central depository or all matters
17 relating to registration of the Consolidated Refunding Bonds under a book-entry system;

18 (g) to select a trust company or other banking institution as trustee, to hold the trust
19 fund into which the proceeds of the sale of any Consolidated Refunding Bonds issued hereunder
20 may be deposited under the Refunding Act, to determine the terms of any such trust fund,
21 including any provisions relating to the payment of costs related to such trust fund, and to deliver
22 as a binding commitment of the County a trust or escrow agreement, pursuant to which such trust
23 fund is established;

24 (h) to arrange for the preparation and distribution of an appropriate Offering Circular,
25 Official Statement or Official Circular with respect to the sale of any series of Consolidated
26 Refunding Bonds hereby authorized; and

27 (i) after considering any recommendations of the County's financial advisor, to
28 reserve to the County the option to redeem or to call for mandatory tender for purchase (and to
29 sell, transfer or convey any such option to call for mandatory tender for purchase) any such
30 series of Consolidated Refunding Bonds in whole or in part, at such times and upon payment of
31 such premiums as the County's financial advisor may recommend.

1 Subject to and in accordance with the provisions of this Act, the County Executive or, if so
 2 provided by order of the County Executive, the Chief Administrative Officer, shall determine by
 3 order, for each and every series of Consolidated Refunding Bonds issued pursuant to and in
 4 accordance with this Act, the matters specified in paragraphs (c), (d), (f), (g) and (i) above and, if
 5 a determination is made to sell any such series of Consolidated Refunding Bonds by soliciting
 6 competitive bids at public sale, the matters specified in paragraph (e) above for such series of
 7 Consolidated Refunding Bonds.

8 SECTION 27. BE IT FURTHER ENACTED that (1) references to "Bonds" in Section 14
 9 of this Act shall be deemed to include the Consolidated Refunding Bonds and (2) references to
 10 "bonds authorized by this Act" in Section 16 of this Act shall be deemed to include the
 11 Consolidated Refunding Bonds, unless the context clearly indicates otherwise.

12 SECTION 28. BE IT FURTHER ENACTED that, pursuant to Section 30 of Article 31 of
 13 the Annotated Code of Maryland, as amended, replaced or recodified from time to time (the
 14 "Registration Statute"), the Bonds, Consolidated Refunding Bonds or Notes issued hereunder
 15 may be issued in "registered form" within the meaning of the Registration Statute, as may be
 16 determined by the County Executive or, if so provided by order of the County Executive, the
 17 Chief Administrative Officer, who may determine, approve or authorize the selection of trustees,
 18 transfer agents, registrars, paying or other agents, a custodian for a central depository or book-
 19 entry system and appropriate agreements with any of the foregoing and such other matters not
 20 inconsistent with this Act necessary or deemed appropriate in connection with the issuance of
 21 Bonds, Consolidated Refunding Bonds or Notes in "registered form" within the meaning of the
 22 Registration Statute.

23 SECTION 29. BE IT FURTHER ENACTED that, the County Executive or, if so provided
 24 by order of the County Executive, the Chief Administrative Officer, by order, is hereby
 25 authorized on behalf of the County, to make such undertakings, covenants or agreements for the
 26 benefit of the holders of the Bonds, the Consolidated Refunding Bonds or the Notes (including,
 27 without limitation, the Program Notes), as applicable, with regard to secondary market disclosure
 28 as shall be necessary or appropriate to comply with the provisions of Securities and Exchange
 29 Commission Rule 15c2-12, as amended, modified or replaced from time to time ("SEC Rule
 30 15c2-12"). Such authority shall include (without limitation) the power to approve and enter into
 31 continuing disclosure or dissemination agreements with any third party; the power to amend or

1 modify any such undertakings, covenants, agreements, or continuing disclosure or dissemination
2 agreements, to the extent permitted by SEC Rule 15c2-12; and the power to provide for the
3 insertion of a description regarding any such secondary market disclosure covenants or
4 agreements in any applicable notice of sale, bond purchase agreement or other purchase contract,
5 and any preliminary or final Official Statement, Offering Circular, Official Circular or similar
6 offering document. Such undertakings, covenants or agreements shall be binding upon the
7 County and the County hereby covenants and agrees to abide by any such undertakings,
8 covenants or agreements made in accordance with this Section for the benefit of the holders of
9 the Bonds, the Consolidated Refunding Bonds or the Notes, as applicable. Any undertaking,
10 covenant or agreement made by the County Executive or the Chief Administrative Officer, as the
11 case may be, pursuant to this Section shall be set forth in or authorized by an order executed by
12 such official.

13 SECTION 30. BE IT FURTHER ENACTED that, to the extent applicable, Sections 817B
14 and 817C of the Charter shall apply to the taxes levied as provided in this Ordinance so long as
15 such Sections shall remain in effect.

16 SECTION 31. BE IT FURTHER ENACTED that if any one or more of the provisions of
17 this Act, including any covenants or agreements provided herein on the part of the County to be
18 performed, should be contrary to law, then such provision or provisions shall be null and void
19 and shall in no way affect the validity of the other provisions of this Act or of the Bonds, the
20 Consolidated Refunding Bonds or the Notes.

21 SECTION 32. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45)
22 calendar days after it becomes law.

Any such interest not punctually paid or duly provided for shall forthwith cease to be payable to the registered owner on such Regular Record Date, and may be paid to the person in whose name this Bond is registered as of the close of business on a date to be fixed by the Bond Registrar for the payment of such defaulted interest (the "Special Record Date"), notice of such payment date and the Special Record Date therefor being given by letter mailed first class, postage prepaid, to the registered owner of such Bond not less than 10 days prior to such Special Record Date, at the address of such owner appearing on the Bond Register, or may be paid at any time in any other lawful manner not inconsistent with the requirements of any securities exchange on which the Bonds of this issue may be listed and upon such notice as may be required by such exchange.

Interest will accrue from the most recent date to which interest has been paid or, if no interest has been paid, from the Original Issue Date shown above.

"County Business Day" means any date of the year on which (i) banking institutions in New York, New York or in Maryland are not authorized or obligated by law to remain closed or on which the New York Stock Exchange is not closed or (ii) the offices of the County are not authorized or obligated by law or required by an executive order of the County Executive to be closed.

All payments of the principal of, redemption price and interest on this Bond shall be in such coin or currency of the United States of America as at the time of payment is legal tender for payment of public and private debts.

REFERENCE IS MADE TO THE FURTHER PROVISIONS OF THIS BOND SET FORTH ON THE REVERSE SIDE HEREOF WHICH SHALL FOR ALL PURPOSES HAVE THE SAME EFFECT AS THOUGH FULLY SET FORTH HEREIN.

The full faith and credit and taxing power of Prince George's County, Maryland are hereby irrevocably pledged to the payment of the principal of this Bond and of the interest payable hereon. To provide for the payment of this Bond, the County is empowered and directed to levy ad valorem taxes upon all the legally assessable property within the corporate limits of the County; such tax levy is subject, however, to the limitation set forth in Section 817B and Section 817C of the County Charter so long as such sections shall be in effect. Section 817B provides, in part, that the County shall not levy "a real property tax which would result in a total collection of real property taxes greater than the amount collected in fiscal year 1979; [except that the County] may levy a real property tax which would result in a total collection of real property taxes greater than the amount collected in fiscal year 1979 if the real property tax rate does not exceed Two Dollars and forty cents (\$2.40) for each One Hundred Dollars (\$100.00) of assessed value." Section 817C provides that any ordinance or resolution levying or charging taxes or certain fees in excess of the amount levied in the preceding fiscal year shall be referred to a referendum of the qualified voters of the County.

The principal of and interest on this Bond are payable from annual appropriations of the proceeds of ad valorem taxes which the County is empowered and directed to levy, subject to said Section 817B and Section 817C limitations, upon all the legally assessable property within the corporate limits of the County. The County has covenanted, subject to said Section 817B and Section 817C limitations, to levy said ad valorem taxes in rate and amount sufficient for such payment in each fiscal year in which provision must be made for the payment of such principal and interest and in the event the proceeds from taxes so levied in any such fiscal year shall prove inadequate for such payment, to levy additional taxes, subject to said limitation, in succeeding fiscal years to make up such deficiency.

It is hereby certified and recited that each and every act, condition and thing required to exist, to be done, to have happened, and to be performed precedent to and in the issuance of this Bond, does exist, has been done, has happened and has been performed in full and strict compliance with the Constitution and laws of the State of Maryland, the County Charter, the Authorization Ordinance, the Enabling Acts of the County and the Executive Orders of the

County Executive referred to herein, and that the issue of Bonds, of which this Bond is one, together with all other indebtedness of the County, is within every debt and other limit prescribed by the Constitution and laws of the State of Maryland and the County.

The County will provide services as Bond Registrar to open books for the registration and for the transfer of registered Bonds. Authority to Issue: The Bonds are to be issued under the authority of Article 25A of the Annotated Code of Maryland (1998 Replacement Volume), the Charter of Prince George's County, Maryland and Council Bill CB-__- 199__.

Purpose: The Bonds are being issued to provide funds for the purpose of the construction, acquisition, improvement or extension of certain capital projects including [school buildings, library and community college facilities, health facilities, fire stations, police and corrections facilities, roads and road rehabilitation, parking facilities, mass transit, solid waste facilities and County buildings and facilities].

Source of Payment: The County has irrevocably pledged its full faith and credit and taxing power for the payment of the principal of and interest on the Bonds. To provide for the payment of the Bonds, the County is empowered and directed to levy ad valorem taxes upon all the legally assessable property within the corporate limits of the County; such tax levy is subject, however, to the limitation set forth in Section 817B and Section 817C of the County Charter so long as such sections shall be in effect. Section 817B provides, in part, that the County shall not levy "a real property tax which would result in a total collection of real property taxes greater than the amount collected in fiscal year 1979; [except that the County] may levy a real property tax which would result in a total collection of real property taxes greater than the amount collected in fiscal year 1979 if the real property tax rate does not exceed Two Dollars and forty cents (\$2.40) for each One Hundred Dollars (\$100.00) of assessed value." Section 817C provides that any ordinance or resolution levying or charging taxes or certain fees in excess of the amount levied in the preceding fiscal year shall be referred to a referendum of the qualified voters of the County.

The principal of and interest on the Bonds are payable from annual appropriations of the proceeds of ad valorem taxes which the County is empowered and directed to levy, subject to said Section 817B and Section 817C limitations, upon all the legally assessable property within the corporate limits of the County. The County has covenanted, subject to said Section 817B and Section 817C limitations, to levy said ad valorem taxes in rate and amount sufficient for such payment in each fiscal year in which provision must be made for the payment of such principal and interest and in the event the proceeds from taxes so levied in any such fiscal year shall prove inadequate for such payment, to levy additional taxes, subject to said limitation, in succeeding fiscal years to make up such deficiency.

Minority Participation: The County encourages each bidder for the Bonds to make a good faith effort to include minority business enterprises in the syndicate purchasing the Bonds. Each bidder is requested to submit with its bid a listing of the initial members of the purchasing syndicate, setting forth the initial contribution of each member and identifying the minority business enterprises in some manner. Upon request, the Director of Finance of the County and the financial advisors to the County will make available a nonexclusive list of underwriters and investment bankers the County has identified as minority business enterprises.

Price and Interest Rate Bid: Each bidder shall submit one bid on an "all- or-none" basis. Each proposal must specify the amount bid for the Bonds which must be at least par and must specify the rate or rates of interest to be paid thereon, in multiples of one-eighth ($1/8$) or one-twentieth ($1/20$) of one percent (1%). Bidders may specify more than one rate of interest to be borne by the Bonds, but all Bonds maturing on the same date must bear interest at the same rate; the difference between the maximum and minimum interest rates specified may not exceed three percent (3%) and the rate named for the Bonds of any one maturity may not be less than the rate named for the Bonds of an earlier maturity.
