**RESOLUTION**

1 A RESOLUTION concerning

2 The Formation of an Agricultural District pursuant to the

3 Maryland Agricultural Land Preservation Foundation Program

4 For the purpose of recommending that the Maryland Agricultural Land Preservation Foundation  
 5 approve the petition of John P. and Donna L. Denison to establish an agricultural district.

6 WHEREAS, a petition filed on March 13, 2002 by John P. and Donna L. Denison requested  
 7 the establishment of an agricultural preservation district for approximately 123 acres of land on  
 8 the south side of Accokeek Road, approximately 0.8 mile west of Gardner Road, as generally  
 9 shown on the attached location map; and

10 WHEREAS, the petition was referred to the Prince George's County Planning Board and  
 11 the Prince George's County Agricultural Preservation Advisory Board for review and  
 12 recommendation; and

13 WHEREAS, the Prince George's County Planning Board found that establishment of the  
 14 proposed agricultural district is compatible with existing and approved county plans and  
 15 recommended approval the petition and establishment of the district; and

16 WHEREAS, the Prince George's County Agricultural Preservation Advisory Board found  
 17 that the Denison property met the qualifying criteria for productivity, size, and location as set by  
 18 the Maryland Agricultural Land Preservation Foundation, and recommended establishment of  
 19 the agricultural district; and

20 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's  
 21 County, Maryland, that the 123 acre tract described in the agricultural district petition filed by  
 22 John P. and Donna L. Denison is recommended to the Maryland Agricultural Land Preservation

1 Foundation for approval; and

2 BE IT FURTHER RESOLVED that this resolution, copies of the petition, and copies of the  
3 letters from the Agricultural Preservation Advisory Board and the Prince George's County  
4 Planning Board, be forwarded by the Clerk of the Council to the County Executive for his  
5 consideration and, upon his approval, transmittal to the Maryland Agricultural Land Preservation  
6 Foundation for appropriate action.
