## RESOLUTION

A RESOLUTION concerning

Fiscal Year 1986-1995

Comprehensive Ten Year Solid Waste Management Plan

FOR the purpose of amending the FY 1986-1995 Comprehensive Ten Year

Solid Waste Management Plan to permit the expansion of the

Brandywine Rubblefill.

WHEREAS, Section 9-515 of the Environment Article of the Annotated Code of Maryland requires that each county adopt and submit to the Maryland Department of the Environment (the Department) a County plan dealing with solid waste disposal systems and solid waste acceptance facilities and permits each county to submit amendments and revisions thereto; and

WHEREAS, Section 9-515 establishes a procedure governing the preparation, adoption and amendment of said plan in Prince George's County; and

WHEREAS, the FY 1986-1995 Comprehensive Solid Waste Management Plan for Prince George's County was adopted by CR-70-1986 and amended by CR-105-1988, CR-38-1989, CR-104-1989 and CR-19-1991; and

WHEREAS, the County Council of Prince George's County,
Maryland, sitting as the District Council did amend the zoning map
for the Maryland-Washington Regional District in Prince George's
County to show approval by means of Special Exception 3035 for a
rubblefill located on Cross Road Trail approximately one mile east
of U.S. Route 301; and

WHEREAS, operation of the Brandywine Rubblefill, approved in Special Exception 3849, is to be conducted in accordance with Sections 21-101 through 21-137 of the Prince George's County Code and certain other conditions as set forth in Special Exception 3849; and

WHEREAS, the County Council received public testimony regarding the expansion of the Brandywine Rubblefill through a duly advertised public hearing; and

WHEREAS, in addition to the normal advertising procedures, the County Council notified the Washington Suburban Sanitary Commission, the Maryland-National Capital Park and Planning Commission, the State and County Health Departments, the Maryland Office of Planning, and the State Department of Natural Resources of the public hearing and provided each agency with a copy of the amending resolution; now, therefore,

SECTION 1. BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the adopted Fiscal Year 1986-1995 Comprehensive Ten Year Solid Waste Management Plan as adopted by -3- CR-50-1991

CR-70-1986 and last amended by CR-19-1991 is further amended as follows:

- a. Amend Chapter Four, Section II. C., entitled "Rubblefills", to read as follows:
- C. Rubblefills. There are three rubblefills: Brandywine, Ritchie-Marlboro, and the B&B Partnership. Their locations are shown on figures 4-4, 4-5, and 4-5c, respectively. The Brandywine Rubblefill is currently operating on approximately 100 acres by virtue of Special Exception 3035, and has approved State and County permits. On November 24, 1988, the District Council approved Special Exception 3849, which not only extended the life of the rubblefill approved in Special Exception 3035 for an additional eleven (11) years, but also permitted its expansion to a total area of approximately 179 acres (Figure 4-4) for the same period of time. State and County permit applications are currently pending to permit this expansion. [and] The Ritchie-Marlboro Road rubblefill[s have] has approved State and County permits and [are] is currently in operation.

- SECTION 2. BE IT FURTHER RESOLVED that within five (5) working days of the adoption of the resolution, it shall be transmitted to the County Executive by the Clerk of the Council.
- SECTION 3. BE IT FURTHER RESOLVED that this resolution shall take effect on the day following the first regularly scheduled Council meeting day which occurs after the County Executive

transmits his comments on this amendment, or ten (10) working days following transmittal of this resolution to the County Executive, whichever shall occur first. Prior to the effective date of this resolution, the Council may reconsider its action based upon any recommendation received from the County Executive.

SECTION 4. BE IT FURTHER RESOLVED that upon the effective date of this resolution it shall be transmitted by the Clerk of the Council to the Secretary of the Maryland Department of the Environment.
