**COMMITTEE OF THE WHOLE REPORT**

Committee Vote: Favorable, 7-2 (In favor: Council Members Hendershot, Knott, Wilson, Bailey, Scott, Esteppe, and Shapiro; Opposed: Russell and Dernoga)

The Council Administrator briefed the Committee of the Whole (COW) on CR-56-2002, explaining the Office of Law concerns. The Office of Law provided written comments pertaining to the authority of drafting amendments to the County Ten-Year Water and Sewer Plan.

CR-56-2002 amends the plan to include a proposed project (Glen Dale Village), consisting of 14 single-family homes. Glen Dale Village is currently in category 5, requesting advancement to

Category 4. The Preliminary Plan was accepted on September 9, 2002. It is scheduled for the Planning Board on November 14, 2002. The Planning Board recommends advancement to Category 4.

**BACKGROUND INFORMATION/FISCAL IMPACT**

This is a water and sewer allocation application from the August cycle. The Executive Branch has decided not to process applications from the August cycle in the usual manner, so it is necessary to process this application individually.
