The requestor seems to have flagged the boat as abandoned; however, the code defines what constitutes an abandoned vehicle. We typically assess an abandoned vehicle as one that is *inoperable* and *left unattended on public property for more than 48-hours*. To determine if a car is inoperable, our team looks for evidence of debris, deflated tires, expired or missing registration plates, or any other sign of inoperability. If a vehicle is found to be *both* inoperable and unattended on public property for more than 48 hours, then it's eligible for impoundment. Alternatively, a vehicle that does not display
