An Interproject Transfer of Appropriations in the Approved Fiscal Year 2009 Capital Budget For the purpose of transferring appropriations to the Greenbelt Middle School Renovation project and the Hyattsville Area Elementary School project.

WHEREAS, the Charter of Prince George's County, Maryland provides for the adoption of the County budget, which includes the capital budget and capital program; and

WHEREAS, pursuant to CB-28-2008, the County Budget, known as the Annual Budget and Appropriation Ordinance of Prince George's County for Fiscal Year 2009, which includes the Fiscal Years 2009-2014 Capital Improvement Program - Fiscal Year 2009 Capital Budget was adopted and amended; and

WHEREAS, the Approved Fiscal Year 2009-2014 Capital Improvement Program sets forth the plan of the County to receive and expend funds for capital projects during the fiscal year covered by the capital budget and the next succeeding five fiscal years thereafter and also the means of financing said projects; and

WHEREAS, pursuant to Section 814 of the Charter for Prince George's County, Maryland, the County Council may authorize, by legislative act, upon request of the County Executive, interproject transfers of appropriations between capital projects in the capital budget; and

WHEREAS, the County Executive deems it desirable to provide additional appropriations through an interproject transfer of appropriations to the Greenbelt Middle School Renovation (AA779413) and Hyattsville Area Elementary School (AA779853) as currently existing appropriations are inadequate; and
