RESOLUTION

The Redevelopment Authority of Prince George's County Fiscal Year

A RESOLUTION concerning

1999-2000 Operating Budget and Capital Improvement Program

For the purpose of approving the Capital Improvement Program of the Redevelopment Authority of Prince George's County for Fiscal Years 2000 -2005, prepared pursuant to the authority contained in Subtitle 15B of the Prince George's County Code and providing comments on the

WHEREAS, Section 15B-124 of the Prince George's County Code provides that the Redevelopment Authority of Prince George's County may propose one or more projects for inclusion in the Authority's Capital Improvement Program and that the County Executive shall transmit to the County Council for its approval by resolution or ordinance any such project approved by the County Executive; and

proposed Operating Budget of the Authority for Fiscal Year 1999-2000.

WHEREAS, the County Executive has proposed for approval a single County-wide project number UM900995 County Revitalization Program, a copy of which is attached hereto; and

WHEREAS, Section 15B-123 of the Prince George's County Code provides that if the proposed operating budget of the Authority includes any item to be funded from payments to be received from the County that the anticipated receipts shall be identified for each item and a copy of the proposed budget shall be transmitted by the Authority to the County Executive and the County Council for their review and comment; and

WHEREAS, the Authority has forwarded its proposed operating budget to the County Executive and the County Council for review and comment.

SECTION 1. NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that subject to and in accordance with the authority of the Charter of Prince George's County and pursuant to Subtitle 15B of the Prince George's County Code, the Capital Improvement Program for Fiscal Years 2000-2005 of the Redevelopment Authority of Prince George's County, as submitted by the County Executive to the County Council, a copy of which is attached hereto and incorporated herein by reference as though it was set forth fully herein, is hereby authorized, approved, and adopted.

SECTION 2. BE IT FURTHER RESOLVED that the County Council has reviewed the proposed Operating Budget, Fiscal Year 1999-2000, of the Redevelopment Authority of Prince George's County and concurs with the proposed Operating Budget of the Redevelopment Authority.
