1 A RESOLUTION concerning

2 The Redevelopment Authority of Prince George's County Fiscal Year

3 1999-2000 Operating Budget and Capital Improvement Program

4 For the purpose of approving the Capital Improvement Program of the Redevelopment Authority  
 5 of Prince George's County for Fiscal Years 2000 -2005, prepared pursuant to the authority  
 6 contained in Subtitle 15B of the Prince George's County Code and providing comments on the  
 7 proposed Operating Budget of the Authority for Fiscal Year 1999-2000.

8 WHEREAS, Section 15B-124 of the Prince George's County Code provides that the  
 9 Redevelopment Authority of Prince George's County may propose one or more projects for  
 10 inclusion in the Authority's Capital Improvement Program and that the County Executive shall  
 11 transmit to the County Council for its approval by resolution or ordinance any such project  
 12 approved by the County Executive; and

13 WHEREAS, the County Executive has proposed for approval a single County-wide project  
 14 number UM900995 County Revitalization Program, a copy of which is attached hereto; and

15 WHEREAS, Section 15B-123 of the Prince George's County Code provides that if the  
 16 proposed operating budget of the Authority includes any item to be funded from payments to be  
 17 received from the County that the anticipated receipts shall be identified for each item and a copy  
 18 of the proposed budget shall be transmitted by the Authority to the County Executive and the  
 19 County Council for their review and comment; and

20 WHEREAS, the Authority has forwarded its proposed operating budget to the County  
 21 Executive and the County Council for review and comment.

1 SECTION 1. NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince  
2 George's County, Maryland, that subject to and in accordance with the authority of the Charter of  
3 Prince George's County and pursuant to Subtitle 15B of the Prince George's County Code, the  
4 Capital Improvement Program for Fiscal Years 2000-2005 of the Redevelopment Authority of  
5 Prince George's County, as submitted by the County Executive to the County Council, a copy of  
6 which is attached hereto and incorporated herein by reference as though it was set forth fully  
7 herein, is hereby authorized, approved, and adopted.

8 SECTION 2. BE IT FURTHER RESOLVED that the County Council has reviewed the  
9 proposed Operating Budget, Fiscal Year 1999-2000, of the Redevelopment Authority of Prince  
10 George's County and concurs with the proposed Operating Budget of the Redevelopment  
11 Authority.
