This resolution amends Prince George's County portion of the FY 2026 Budget for the Maryland-National Capital Park and Planning Commission (M-NCPPC) to reallocate funding within the Commission's Recreation Fund. Within the approved FY 2026 budget, the Council set aside \$6.3 million for potential programming opportunities for the Department of Parks and Recreation as well as \$14.7 million for reimbursable recreation activities carried out by local organizations (project charges). Since the passage of the budget in May 2025, the Council has identified new partnership opportunities and recreational needs which can be fulfilled through its Council-directed pilot program. Accordingly, this resolution reallocates funds from specific projects set forth in the resolution to the County Council's pilot for recreation programming.

This Resolution was introduced by Council Members Oriadha and Burroughs and referred to the Committee of the Whole.

QUALIFICATION REQUIREMENTS: Individuals must be a resident of Prince George's County and a have been a qualified voter of their respective Council district for at least one year.

The County Council of Prince George's County, Maryland, will hold the following informational briefing for the public to hear from those under consideration by the Council.
