AN ACT CONCERNING PRINCE GEORGE’S COUNTY SENIOR HOUSING ASSISTANCE PROGRAM ACT OF 2023

for the purpose of establishing the Prince George’s County Senior Housing Assistance Program; establishing the Prince George’s County Senior Housing Assistance Fund; providing financial rental assistance to Prince George’s County senior residents based on AMI level; providing mortgage payment assistance to Prince George’s County senior residents based on AMI level; providing for County property tax payment assistance based on AMI level; providing for the application for County property tax payment assistance, mortgage payment assistance, and County property tax assistance; providing for certain eligibility criteria; providing for certain limitations; and generally providing for senior housing assistance.
