hearing held; case taken under advisement

Prior to Oral Agument hearing, Stan Brown, People's Zoning Counsel, provided a procedural clarification indicating that the appeal filed in this case is invalid, due to the appellants' failure to demonstrate "aggreivement," as now required by State law. He indicated that the hearing would still move forward because the Council elected to review the case on its own. Cynthia Fenton, M-NCPPC, provided an overview of the Detailed Site Plan application.
