9 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,
 10 Maryland, that Section Sec. 21-125.03 of the Prince George's County Code be and the same is
 11 hereby repealed and reenacted with the following amendments:

12 SUBTITLE 21. REFUSE.

13 DIVISION 1. REFUSE COLLECTION AND DISPOSAL.

14 SUBDIVISION 1. REFUSE AND COLLECTION

15 **Sec. 21-125.03. Commission composition; term; officers.**

16 (a) The Commission shall be composed of [fifteen (15) members] nine (9) members
 17 appointed by the County Executive and subject to the confirmation by the County Council. At
 18 least five (5) of the appointments, one of whom shall be designated as the vice chairman, shall be
 19 selected from a list of persons submitted by the County Council. One (1) ex-officio member may
 20 be appointed by the County Executive and one (1) ex-officio member may be appointed by the
 21 County Council. Members shall be selected so as to represent broad geographic areas of the

1 County, the solid waste industry, business users, environmental, public health and civic
 2 community and the general public, at least one member shall be appointed from the communities
 3 surrounding the Brown Station Road landfill.

4 (b) The term of office for each member shall be three (3) years [; however, the terms of the
 5 initial appointments shall be staggered with five (5) members appointed to three (3) year terms,
 6 five (5) members appointed to two (2) year terms, and five (5) members appointed to one (1)
 7 year terms.]

8 * * * * *

9 SECTION 2. BE IT FURTHER ENACTED that the provisions of this Act are hereby
 10 declared to be severable; and, in the event that any section, subsection, paragraph, subparagraph,
 11 sentence, clause, phrase, or word of this Act is declared invalid or unconstitutional by a court of
 12 competent jurisdiction, such invalidity or unconstitutionality shall not affect the remaining
 13 words, phrases, clauses, sentences, subparagraphs, paragraphs, subsections, or sections of this
 14 Act, since the same would have been enacted without the incorporation in this Act of any such
 15 invalid or unconstitutional word, phrase, clause, sentence, paragraph, subparagraph, subsection,
 16 or section.

17 SECTION 3. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45)
 18 calendar days after it becomes law.
