

## LEAD AGENCY AND RESPONSIBILITIES



The Department of Housing and Community Development (DHCD) is the lead agency responsible for the administration of the following federal entitlement programs on behalf of HUD:

- Community Development Block Grant (CDBG),
- HOME Investment Partnerships (HOME), and
- Emergency Solutions Grants (ESG).

DHCD partners with the Prince George's County Department of Social Services (DSS) to implement the ESG program.

In addition to administering the programs, DHCD is responsible for the preparation of the:

- Consolidated Plans (Con Plans),
- Annual Action Plans (AAPs), and
- Consolidated Annual Performance and Evaluation Reports (CAPERs).

# PRINCE GEORGE'S COUNTY CONSOLIDATED PLAN AND HOUSING OPPORTUNITIES FOR ALL

The Housing and Community Development Act of 1974, as amended, and the National Affordable Housing Act of 1990, require the submission of a Consolidated Plan to undertake a program and activities to meet housing and community development needs and priorities principally for low to moderate-income residents.

Prince George's County's Consolidated Plan for FY 2021 – 2025 builds on the analysis presented in *Housing Opportunity for All*, the County's first 10-year CHS, and directly supports implementation of more the actions from the CHS.

The FY 2023 Annual Action Plan supports Prince George's County's implementation of the FY 2021-2025 Consolidated Plan by leveraging the annual allocations of CDBG, HOME, and ESG entitlement fund resources to develop viable communities of choice.
