The Committee convened on May 12, 2022 to review CR-33-2022, which authorizes the Director of the Prince George's County Department of Public Works and Transportation to file applications for Fiscal Year 2023 for various federal and state grants. This continuing resolution includes authorization of *provisions for a local share* (County Match) of cost for certain projects and requiring the governing body to authorize the *filing of grant applications* and *formal acceptance of awarded grant funding*. This is an annual exercise that authorizes anticipated local, state and federal formula and discretionary funding with the Maryland Department of Transportation (MDOT) and its offices and modal administrations including the Maryland Transit Administration (MTA) and Maryland Highway Safety Office, U. S. Department of Homeland Security (DHS), U. S. Department of Transportation (USDOT), and its offices and modal administrations including the Federal Transit Administration (FTA) and the Federal Highway Administration (FHWA), the U.S Department of Energy (DOE), the U.S Environmental Protection Agency (EPA) and the Metropolitan Washington Council of Governments (MWCOG) for a variety of state and federal grant programs. CR-33 endorses DPWT's applications for the following grants (amounts are included as information is available):

DPWT staff (Oluseyi Olugbene - Deputy Director, Semia Hackett - Associate Director, Victor Weissberg - Major Projects Coordinator and Canjor D. Reed - Fiscal Coordinator and Chief of Finance) provided comments on the FY 2023 grant application package, which is becoming more stream-lined. CR-33-2022 also authorizes the application for the apportionment for the Washington, DC/VA/MD urbanized area, which is being administered through the Metropolitan Washington Council of Governments (MWCOG), as well as any additional or remaining funding from the CRSSA, the Coronavirus Aid, Relief, and Economic Security (CARES) Act, the American Rescue Plan Act of 2021, or other unanticipated Federal funding programs that would require application during Fiscal Year 2023.

After the discussion, the Committee voted favorably on CR-33-2022 by a vote of 4-0.
