**BACKGROUND INFORMATION/FISCAL IMPACT:**

This Resolution is for the purpose of authorizing the Director of the Prince George's County Department of Public Works and Transportation ("DPW&T") to file applications for Fiscal Year 2023 with the Maryland Department of Transportation (MDOT), U. S. Department of Homeland Security (DHS), U. S. Department of Transportation (USDOT), Federal Transit Administration (FTA), the Federal Highway Administration (FHWA), U.S. Environmental Protection Agency (EPA), U.S. Department of Energy (DOE) and Metropolitan Washington Council of Governments (MWCOG).

Applications for financial assistance under certain grant programs of the aforementioned Agencies impose certain obligations upon the applicant. This includes providing a local share of cost for certain projects and requiring the governing body of Prince George's County by Resolution to authorize the filing of grant applications and formal acceptance of awarded grant funding.

Additionally, the United States Department of Transportation, in accordance with the provisions of the Title VI of the Civil Rights Act of 1964, requires an applicant for assistance under the Federal Transit Act to give assurances that it will comply with Title VI of the Civil Rights Act of 1964 and the United States Department of Transportation requirements thereunder.
