10	(a) Private Retreat Center uses a permitted (P) in the Residential Table of Uses in the R-A
11	Zone, subject to the following requirements:
12	(1) General Requirements.
13	(A) The use is located on property with a land area greater than thirty (30) acres;
14	(B) The use is located in the Rural and Agricultural Area as identified in the
15	Growth Policy Map of the County's General Plan, as may be amended from time to time.
16	(C) The use shall be owned and operated by a private, non-profit organization;
17	<u>and</u>
18	(D) There shall be no permanent residents of the property on which the use is
19	located, except in a caretaker and/or staff residence.
20	(2) Site Plan.
21	(A) A Detailed Site Plan shall be approved for the use, in accordance with Part 3
22	Division 9, of this Subtitle, to insure compliance with the provisions of this Section.
23	(B) In addition to the requirements of Part 3, Division 9, the applicant shall
24	comply with the Prince George's County Landscape Manual;
25	(3) Accessory Uses.
26	In addition to compatible accessory uses permitted pursuant to Sec. 27-441, a limited number of
27	cottages/hermitages, not to exceed five (5) units, shall be permitted as guest lodging accessory to
28	the Private Retreat Center use.
