BACKGROUND INFORMATION/FISCAL IMPACT:

This resolution will provide supplementary appropriations and amends the Fiscal Year 2023-2028 Capital Improvement Program of the Redevelopment Authority of Prince George's County. The Redevelopment Authority received a total of \$1,350,000 in State grants to support various capital projects. Grant funding \$850,000 is provided for the Suitland Manor Redevelopment project (8.90.0003). This funding will support the redevelopment of a vacant and blighted former laundry facility into a multi-tenant commercial site as well as acquire and demolish an old 15-unit building to redevelop into townhomes. Grant funds totaling \$500,000 have been awarded for the Addison Road/Capitol Heights Metro Corridor project (8.90.0002) for various community enhancement projects and property acquisitions.
