BACKGROUND INFORMATION/FISCAL IMPACT:

This bill provides that by February 1, 2023, food service businesses shall provide accessory disposable food service ware only upon request by the customer or at a self-serve station. Take-out or delivery orders shall not include accessory disposable food service ware unless specifically requested by the customer in person, on the phone, or online.
