






10 Year Plan to Prevent and End Homelessness 2012-2021

Select Highlights



Strategy 1: Coordinated Entry

- ✓ Universal CoC prioritization and centralized placement system launched April 2015 and updated with the current composite scoring tool in 2021;
- ✓ Street Outreach initiative launched February 2016; expanded to a full team January 2020

Strategies 2, 3 & 4: Prevention Assistance, Shelter Diversion & Rapid Rehousing (RRH)

- ✓ Centralized financial assistance clearinghouse to reduce duplication and turnaround time
- ✓ Increased annual funding from \$188,431 in 2012 to \$1,031,189 in 2022
- ✓ Added 3 RRH programs and 1 TH-RRH program increasing customer unit choice
- ✓ Extended post placement stabilization service to 18 months to reduce recidivism

Strategy 5: Permanent Housing

- ✓ Added 2 new PSH programs
- ✓ Added 3 new RRH programs
- ✓ Increased Permanent Housing funding from \$2,650,047 in 2012 to \$4,913,800 in 2012
- ✓ Increased housing units through partnerships with local housing authorities by 200 units

Current 10 Year Plan – Special Populations

Select Highlights



Unaccompanied youth and young adults

- ✓ Opened Promise Place, a shelter for unaccompanied youth / young adults under 25
- ✓ Selected as a YHDP site increasing youth homeless funding from \$0 in 2012 to \$1.74M in 2022
- ✓ Published a Coordinate Community Plan with goals, objectives and strategies for preventing and ending youth homelessness
- ✓ Launched a Youth Action Board comprised of youth with lived experience
- ✓ Increased housing units through partnerships with local housing authorities by 100 units

Domestic violence, trafficking and sexual assault survivors

- ✓ Added 1 RRH program
- ✓ Partnered with DFS to fund a small prevention/rapid rehousing financial assistance program

Seniors and aging

✓ Partnered with the Housing Authority to create housing preferences for no/extremely low (under 30% AMI) seniors and disabled experiencing long term, chronic homelessness

Veterans

✓ Increased housing units through partnerships with local housing authorities and the VA by 50 units

NEW 10 Year Plan to Prevent and End Homelessness 2023-2032

Focus of Fall/Winter 2022:

- ✓ **EQUITY:** Regional Racial Equity Analysis in partnership with C4 Innovations, Metropolitan Washington Council of Governments and 9 area CoC's
- ✓ **SEVERE SERVICE NEED:** Development of a targeted CoC plan to serve individuals and families with high service needs (severe somatic and behavioral health challenges reported by 53% of all individuals experiencing homelessness) with 6 key goals:
 - 1. Improve outreach and emergency response
 - Address root causes
 - 3. Improve healthcare access and outcomes
 - 4. Increase permanent housing options
 - 5. Improve connections to community supports
 - 6. Improve knowledge building and sharing
- ✓ **TECHNICAL ASSISTANCE:** Partnering with 4 technical assistance providers with subject matter expertise in behavioral health systems integration, community inclusion and equity, unsheltered homelessness / lived experience as experts, housing development and fund braiding, data quality and analysis/data driven decision-making, and overall strategic planning
- ✓ **STAFFING:** Hiring and training of key vacant CoC leadership positions
