**BILL**

1 AN ACT concerning

2 The Classification Plan for Prince George's County

3 For the purpose of adding certain existing classes of work to the bargaining unit represented by  
 4 Prince George's Correctional Officers' Association, Inc. (PGCOA) (Civilian Unit), Salary  
 5 Schedule "Q". This is being done in accordance with the Collective Bargaining Agreement  
 6 made by and between Prince George's County, Maryland and the PGCOA for Fiscal Years 2023  
 7 and 2024.

8 WHEREAS, the County Executive, pursuant to Section 903 of the Prince George's County  
 9 Charter and Section 16-125(a) of Subtitle 16 of the Prince George's County Code, has, in order  
 10 to provide better governmental services, recommended to the County Council amendments to the  
 11 Classification Plan for Prince George's County with respect to certain classes of work described  
 12 within Section 1 of this Bill; now, therefore,

13 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,  
 14 Maryland, that the Classification Plan for Prince George's County be and the same is hereby  
 15 amended as follows:

SECTION 2. BE IT FURTHER ENACTED that the provisions of this Act are hereby declared to be severable; and, in the event that any section, subsection, paragraph, subparagraph, sentence, clause, phrase, or word of this Act is declared invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the remaining words, phrases, clauses, sentences, subparagraphs, paragraphs, subsections, or sections of this Act, since the same would have been enacted without the incorporation in this Act of any such invalid or unconstitutional word, phrase, clause, sentence, paragraph, subparagraph, subsection, or section.

SECTION 3. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45) calendar days after it becomes law.
