RESOLUTION

A RESOLUTION concerning

Contract Approval

For the purpose of a Resolution pursuant to the Prince George's County Charter Section 819 for approval of a multi-year Consultant Services Agreement. The Department of the Environment (DoE) is requesting approval of a contract for financial-related, project and economic-related technical assistance and analysis services for environmental and climate action programs pursuant to Section 819 of the Prince George's County Charter. The contract has been included in an enhancement package for the FY24 Operation Budget request. The contract is a multi-year agreement in the not-to-exceed amount of Two Million Dollars (\$2,000,000.00). The contract provides professional support services to assist County staff, the Climate Action Implementation Task Force and the Resident Advisory Group for Climate Action and Environmental Justice with developing the County's Climate Action Plan Implementation Strategy in accordance with Executive Order No. 5 – 2022 and Council Resolution CR-32-2022. DoE has secured approvals from the Office of Law and Risk Management in accordance with the attached Consultant Services Agreement (Environmental Finance Technical Support and Analysis), Attachment A; and

WHEREAS, DoE's mission is to protect and enhance the quality of life in the greater Prince George's County community through the conservation, preservation, restoration of the environment, guided by the principles of science, resource management, sustainability and stewardship; and

WHEREAS, DoE accomplishes its mission through its Divisions of Sustainability, Resource Recovery, Stormwater Management and Animal Services. The Sustainability Division (the "Division") oversees a broad range of programs, including those pertaining to climate action

planning, climate resilience, air quality, energy conservation, sustainability, forestry and trees, environmental compliance (water, air and noise complaints), illegal dumping and litter, residential drainage, nuisance flooding, floodplain management, capital improvements, environmental justice, environment policy, etc.; and

WHEREAS, the University of Maryland Environmental Finance Center ("Consultant"), under the auspices of the University of Maryland and located at the College Park campus, provides a range of technical assistance services relating to finance and economics to develop the organizational capacity of local governments, and to support effective implementation and financing of environmental protection and resource management projects; and

WHEREAS, the Consultant has staff with expertise in a diverse range of areas, including water resources, economics, stormwater management, policy analysis, air quality, climate change, sustainable development, energy and fiscal planning. Moreover, the Consultant has provided services through the University of Maryland over the last 20-years; and

WHEREAS, The County desires to engage the Consultant to provide technical assistance and analysis support to a variety of projects which is critical for; (a) assessing the effectiveness of the County's measures and initiatives, (b) evaluating targeted sources for the funding of a broad range of projects, and (c) enabling the County to better direct limited resources to projects demonstrating the most need.

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the Contract and Proposal collectively described in Attachment A, and the same is hereby approved, pursuant to Section 819 of the Charter.

BE IT FURTHER RESOLVED that the County Executive is hereby authorized to make any modifications, adjustments, corrections or any other changes as may be necessary finalize the agreement in any manner the County Executive may deem necessary or proper but not altering its substance.
