RESOLUTION

1 A RESOLUTION concerning

2 After-Hours Permit Fee

3 For the purpose of adopting a fee for the review and issuance of an After-Hours permit.

4 WHEREAS, an After Hours Permit Fee must be established to cover the activity of
 5 construction outside of the permitted construction hours; and

6 WHEREAS, the proposed fee will cover the Department of Permitting, Inspections and
 7 Enforcement (“DPIE”) costs of reviewing and issuing an After Hours Permit Fee; and

8 WHEREAS, the After Hours Permit Fee shall be adopted and collected per the fee
 9 prescribed in the Table of Fees; and

10 WHEREAS, pursuant to Section 2-253.63 of the Prince George’s County Code, the DPIE
 11 shall establish and maintain a table of fees for all types of permits and such table shall be
 12 published on the DPIE website; and

13 WHEREAS, pursuant to Section 2-253.63 of the Prince George’s County Code, the
 14 Director of DPIE or County Council shall have the authority to change the fees as deemed
 15 necessary; and

16 WHEREAS, prior to changing the fees, DPIE must hold a public information session to
 17 allow for public comment, must submit the fee changes to the County Executive for approval,
 18 and then must submit the fee changes to County Council by Resolution for approval after notice
 19 and a public hearing; and

20 WHEREAS, Attachment A is the proposed Table of Fees including the After Hours Permit
 21 Fee, attached hereto and made a part of the record hereof; and

22 WHEREAS, the County Executive reviewed such changes and approved the increase as

1 appropriate and necessary.

2 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
3 County, Maryland, that [Special Event Expedited Review Fee] the After-Hours Permit Fee,
4 established, maintained, and published by the Department of Permitting, Inspections and
5 Enforcement as described in the Table of Fees set forth in Attachment A attached hereto and
6 made part of the record hereto of is approved as appropriate and necessary.
