Legislative Summary:

CR-051-2023, proposed by the Chair at the request of the County Executive and sponsored by Council Members Dernoga and Burroughs, was presented on May 16, 2023, and referred to the Government Operations and Fiscal Policy Committee (GOFP). CR-051-2023 would approve 1 approve various County contracts for software products, Geographic Information System (GIS) license and hosting, audio-visual modernization, security operations and software, IT hardware, consultant and technical services, digitization, data center hosting, desk, and telecommunication services.

Current Law/Background:

Under Section 819^1 of the Charter for Prince George's County, Maryland, the County Council must approve, by resolution, all multiyear contracts exceeding an aggregate of Five Hundred Thousand Dollars (\$500,000). Further, in accordance with Section $10-105(c)^2$ of the Prince George's County Code, the County Executive must annually submit a report listing certain multiyear personal service contracts for the coming fiscal year exceeding an aggregate of One Hundred Thousand Dollars (\$100,000) per contractor, and all other executory multiyear contracts for the coming fiscal year exceeding an aggregate of Five Hundred Thousand Dollars (\$500,000), as budgeted, for public review, comment, and approval action by the County Council.

Discussion/Policy Analysis:

The contracts subject to approval are detailed within Attachments A through L to the Resolution. They are as follows:

- Attachment A includes a multiyear services contract for Microsoft Suite Products from Microsoft over Fiscal Years 2024, 2025, and 2026, with an effective date of July 1, 2023, in the estimated amount of \$16,833,226.
- Attachment B includes a multiyear services contract for GIS Enterprise License Agreement and hosting from Environmental Systems Research Institute (ESRI) over Fiscal

Years 2024, 2025, 2026, 2027, 2028, and 2029 with an effective date of October 1, 2023, in the amount of \$5,258,362.

- Attachment C includes a multiyear services contract from Various Audio Visual (AV) Suppliers, such as GMG Media World, LLC and E-Logic, Inc, over Fiscal Years 2024, 2025, and 2026, with an effective date of July 1, 2023, in the estimated amount of \$3,000,000.
- Attachment D includes a multiyear services contract for SmartNet from E-Plus Technology, Inc. over Fiscal Years 2024, 2025, and 2026, with an effective date of July 1, 2023, in the estimated amount of \$2,085,687.
- Attachment E includes a multiyear services contract for Security Operations Center (SOC) from E-Plus Technology, Inc. over Fiscal Years 2024, 2025, and 2026, with an effective date of July 1, 2023, in the estimated amount of \$1,738,272.
- Attachment F includes a multiyear services contract for IT hardware services from Various Supplies, such as Oakland Consulting Group, N2Grate, and CDW Government, over Fiscal Years 2024, 2025, and 2026, with an effective date of October 1, 2023, in the estimated amount of \$3,000,000.
- Attachment G includes a multiyear services contract for Various Suppliers of commercial software, such as CAS Severn and Carahsoft, over Fiscal Years 2024, 2025, and 2026, with an effective date of September 1, 2023, in the estimated amount of \$3,578,685.
- Attachment H includes a multiyear services contract from thirty-one (31) Various IT Professional Consultant Technical Services, such as Broadband Connections, CloudForce, Infojini, Inc., and SNAP, Inc, over Fiscal Years 2024, 2025, and 2026, with an effective date of July 1, 2023, in the estimated amount of \$31,414,099.
- Attachment I includes a multiyear services contract for Various Suppliers of Digitization of Files and Documents, such as Metropolitan Archives and NGEN, LLC, over Fiscal Years 2024, 2025, and 2026, with an effective date of July 1, 2023, in the estimated amount of \$1,500,000.
- Attachment J includes a multiyear services contract for Data Center Hosting from NGEN over Fiscal Years 2024, 2025, 2026, 2027, and 2028 with an effective date of July 1,2023, in the estimated amount of \$5,531,000.
- Attachment K includes a multiyear services contract for Telecommunication Platform and Services from Avaya Corporation (Avaya) over Fiscal Years 2024, 2025, and 2026, with an effective date of January 1, 2024, in the estimated amount of \$4,170,131.
- Attachment L includes a multiyear services contract for Wireless Telecommunication Utility Services from Verizon Wireless over Fiscal Years 2024, 2025, and 2026, with an effective date of January 1, 2024, in the estimated amount of \$825,600.

The maximum disbursement amount of the contracts for FY 2024 through FY 2026 is approximately \$78,935,062. All contracts have an optional extension available should it be required.

By Attachment and Vendors, the FY 2024 through FY 2026 cost breakdown is as follows:

Adoption of CR-051-2023 will have an adverse fiscal impact as it would authorize contracts resulting in additional expenditures of \$78,935,062 between Fiscal Years 2024 through 2029 and should not have an impact on revenues.
