EXPLANATION OF ADJUSTMENTS

Police Department

The U.S. Department of Justice, Office of Justice Programs awarded \$260,000 for the FBJA Capacity Enhancement for Backlog Reduction Program. Funding supports the backlog in deoxyribonucleic acid (DNA) processing.

The National Institute of Justice awarded \$285,368 for the NIJ Forensic Casework DNA Backlog Reduction program. Funding supports existing crime laboratories that conduct DNA analysis to handle, screen and analyze backlogged forensic DNA casework samples, as well as to improve DNA laboratory infrastructure and analysis capacity. Additional appropriation authority in the amount of \$68,468 is needed to fully expend the award received.

The Governor's Office on Crime Prevention, Youth and Victim Services awarded \$644,456 for the Coordinated Localized Intelligence Project. Funding provides a robust crime intelligence system that meets the criteria set by the Maryland Criminal Intelligence Network (MCIN). Funds will be used for overtime, personnel, contractual services and equipment. Additional appropriation authority in the amount of \$136,956 is needed to fully expend the award received.

The Maryland Department of Transportation awarded \$10,000 for the Commercial Vehicle program. Funding support overtime for personnel to conduct commercial motor vehicle enforcement and inspections.

The Maryland Department of State Police awarded \$731,777 for the License Plate Reader Grant. Funding will support the purchase of license plate readers to benefit highway safety.

The Governor's Office on Crime Prevention, Youth and Victim Services awarded \$214,968 for the Police Accountability, Community and Transparency Grant (PACT). Funding enhances the training and education of new and existing law enforcement officers.

The Maryland – National Capital Region Emergency Response System awarded \$75,000 for the Small Unmanned Aerial Systems program. Funding will provide classroom-based training and exercises.

The Governor's Office on Crime Prevention, Youth and Victim Services awarded \$100,000 for the FY23 BJAG Project. Funding supports community intervention and narcotic enforcement.

The Governor's Office on Crime Prevention, Youth and Victim Services awarded \$297,457 for the Project Safe Neighborhood II. Funding supports overtime and equipment purchases for law enforcement.

The District of Columbia, Homeland Security and Emergency Management Agency awarded \$188,000 for the Urban Areas Security Initiative (UASI) Tactical Equipment for Law Enforcement grant. Funds will be used to support equipment purchases.

The Government of the District of Columbia, Homeland Security and Emergency Management Agency awarded \$506,000 for the Law Enforcement Tactical Equipment and Vehicle Enhancement for Law Enforcement grant. Funds will be used to support emergency mobile and portable equipment purchases.

The Government of the District of Columbia, Homeland Security and Emergency Management Agency awarded \$60,000 for the Small Unmanned Aerial Systems grant. Funds will be used to support unmanned aerial equipment, vehicle and accessories.

The Maryland State Police via the Vehicle Theft Prevention Council awarded \$425,000 for the Vehicle Theft Prevention Program. Funds support auto theft deterrence.

The National Institute of Health awarded \$50,085 in funding for the Coverdell Forensic Science Improvement grant to assist with DNA case analysis and study. Additional appropriation authority in the amount of \$10,585 is needed to fully expend the award.

Fire/EMS Department

The State of Maryland Military Department Fifth Regiment awarded funding \$1,724,997 for the Senator William H. Amoss 508 Funds. Funds support volunteer fire, rescue, and ambulance companies. An additional appropriation totaling \$49,897 is needed to expend the full award.

Pulse Point Marketing awarded \$1,000 for the purchase of branded keychain face shields and gloves.

The International Association of Fire Chief's (IAFC) Workforce Solutions awarded \$5,000 for the Camp Fire program. Funding provides scholarships to recruit women and other underrepresented groups into the fire service.

Office of Homeland Security

The Maryland Emergency Management Agency awarded \$362,354 in funding to enhance local emergency management capacity. Additional appropriation authority totaling \$61,554 is needed.

The District of Columbia, Homeland Security and Emergency Management Agency awarded \$199,394 for the Urban Areas Security Initiative (UASI) Response and Recovery Planning. Funds will be used to plan for jurisdictional and regional recovery efforts.

Department of Family Services

The Governor's Office of Crime Prevention, Youth, and Victim Services Office awarded funding in the amount of \$2,158,964 for the Community Partnership Agreement grant. This program provides community support to increase and create international recruitment for persons with children living with economic challenges so these families can improve the economic conditions of their families and in turn, decrease food insecurities. Additional appropriation authority in the amount of \$143,014 is needed to fully expend the award received.

The Maryland Department of Aging awarded funding in the amount of \$121,597 for the State Ombudsman grant. This program provides funding for complaint investigations and advocacy

services to all residents living in long-term care facilities, licenses assisted living group homes and nursing homes. Additional appropriation authority in the amount of \$3,097 is needed to fully expend the award received.

The Maryland Department of Aging awarded funding in the amount of \$55,732 for the Money Follows the Person Options Counseling grant. This program provides assistance to residents who are transitioning from an institution back into the community. Additional appropriation authority in the amount of \$6,732 is needed to fully expend the award received.

The Maryland Department of Aging awarded funding in the amount of \$612,698 for the Senior Assisted Living Subsidy grant. This program provides funding for subsidy payments for providers who are assisting residents in group homes. Additional appropriation authority in the amount of \$34,098 is needed to fully expend the award received.

The Governor's Office of Crime Prevention Youth and Victim Services awarded funding in the amount of \$53,000 for the Domestic Violence Centers grant. This program provides funding for direct victim assistance and stabilization for victims/survivors in Prince George's County. The program will assist survivors and their families in achieving a greater level of independence, strengthen the families to cope with healing and rebuilding the family unit by removing various challenges to housing, improving safety, and gaining self-sufficiency. Direct service assistance to survivors with safety planning, housing assistance, counseling, and other basic needs are provided.

This program provides funding for assistance to caregivers by providing information, assistance, individual counseling, training, respite care, supplemental services, and support groups.

The Maryland Department of Aging awarded funding in the amount of \$319 for the FY22 Title VII Ombudsman grant. This program provides funding for advocacy for residents of nursing homes and assisted living facilities by providing a voice for those who are unable to speak for themselves. This grant promotes residents' rights through facility visits, facility staff training, and workshops.

The Maryland Department of Aging awarded funding in the amount of \$27,917 for the FY22 Title IIIB Guardianship grant. This program provides funding for County residents concerning the programs and assistance available related to guardianship issues.

The Maryland Department of Aging awarded funding in the amount of \$44,422 for the FY22 Title IIIB Info & Referral grant. This program provides funding for information to County residents concerning the programs and assistance available.

The Maryland Department of Aging awarded funding in the amount of \$247,568 for the Title IIIB Information and Referral grant. Additional appropriation authority totaling \$44,968 is needed full expend the award received.

The Center for Workforce Inclusion awarded \$502,300 in funding to support the Senior Training and Employment Program. Additional matching funds totaling \$12,467 are required to support program operations. Funds provide work experience and training for low-income seniors.

The Maryland Department of Aging awarded funding for the State Guardianship program and case management service for court-referred individuals and for whom the Agency Director is the appointed legal guardian. Additional appropriation authority of \$5,500 is needed for the program income earned from service delivery.

Maryland Department of Aging awarded funding in the amount of \$341,381 for the Title IIIB Administration grant. Title III-B provides funding for comprehensive planning, monitoring and evaluation of all senior citizen programs in the County. Additional appropriation authority totaling \$47,281 is needed to expend the award received.

The Maryland Department of Aging awarded funding totaling \$87,534 for the Title IIIB-Elder Abuse Prevention grant. Additional appropriation authority totaling \$8,434 is needed to expend the award received.

The Maryland Department of Aging awarded funding totaling \$35,013 for the Title IIIB-Guardianship grant. Additional appropriation authority totaling \$6,813 is needed to expend the award received.

Maryland Department of Aging awarded funding in the amount of 163,840 for the FY22 Title IIIB Subgrantee grant. Additional appropriation authority totaling \$8,840 is needed to expend the award received.

Additional appropriation authority totaling \$4,796 is needed to

expend the award received.

The Maryland Department of Aging awarded \$1,336,994 for the Senior Care program. Funding supports coordinated, community-based, in-home services to seniors with disabilities who may be at risk of nursing home placement. Additional appropriation authority totaling \$283,794 is needed to expend the award received.

Health Department

The Maryland Department of Health awarded \$502,712 for the Prevention Services program. Funding support a media campaign for community outreach services to prevent illegal drug involvement. Additional appropriation authority in the amount of \$12 is needed to fully expend the award received.

The Maryland Department of Health awarded \$145,833 for the Tobacco Use Diabetes program. Funding will advance health equity by identifying and eliminating tobacco, diabetes, and chronic disease related inequities and disparities.

The Maryland Governor's Office of Crime Prevention, Youth and Victim Services awarded \$1,214,610 for the Prince George's County Drug Grant (Project Safety Net). Funding will reduce substance abuse as a factor for the criminal justice system entry and recidivism. Additional appropriation authority in the amount of \$10 is needed to fully expend the award received.

Additional appropriation authority in the amount of \$3,000 is needed to fully expend the award received.

The Maryland Department of Health award \$333,839 for the Strengthening Local Health Dept Infrastructure. Funding will support responding to the economic and public health impacts of COVID-19 and their efforts to contain impacts on their communities, residents and business.

The Maryland Department of Health awarded \$68,500 for the Hepatitis B Prevention program. Funding will support Hepatitis B screening, prevention, immunization, education and outreach services in order to reduce risk to the public. Additional appropriation authority in the amount of \$6,300 is needed to fully expend the award received.

The District of Columbia Department of Health awarded \$979,927 for the Ending the Epidemic HRSA. Funding supports compensation, social media and the expansion of services to individuals disproportionally impacted by human immunodeficiency viruses (HIV) and acquired immunodeficiency syndrome (AIDS). Additional appropriation authority in the amount of \$163,321 is needed to fully expend the award received.

The Maryland Department of Health awarded \$80,000 for the Project W. Funding will provide access to care for pregnant and postpartum women at an increased risk for severe illness from COVID-19.

The State of Maryland Opioid Operational Command Center awarded \$203,808 for the Opioid Operation Command Center. Funding will support public awareness efforts on topics including: risks of opioid use; naloxone administration; risks of fentanyl; stigma; crisis hotlines; Good Samaritan law; trauma and mental health; proper storage and disposal of medication. Additional appropriation authority in the amount of \$15,508 is needed to fully expend the award received.

The Maryland Department of Health awarded \$678,640 for the Local Health Departments Health

Disparities. Funding will address the COVID-19 health risk among the high risk and underserved populations.

The Maryland State Department of Education through the Maryland Department of Health awarded 569,953 for the School Based Health Wellness Center. Funding will ensure that schoolaged children and youth are healthy and ready to learn through increased access and availability of quality, comprehensive healthcare. Additional appropriation authority in the amount of \$226,853 is needed to fully expend the award received.

The Maryland Department of Health awarded \$126,000 for the Surveillance and Quality Improvement program. Funding supports improved outcomes for at-risk pregnant women, decrease infant mortality and maternal and infant health. Additional appropriation authority in the amount of \$12,900 is needed to fully expend the award received.

The Maryland Department of Health awarded \$29,851 for the Title X Telehealth program. Funding will establish telehealth for family planning services in local health departments (LHDs) and will enhance and expand telehealth services in sites with existing telehealth services.

The Maryland Department of Health awarded \$155,847 for the Cities Readiness Initiative. Funding will enhance preparedness in the nation's largest population centers to effectively respond to large public health emergencies needing lifesaving medicines and medical supplies. Additional appropriation authority in the amount of \$24,647 is needed to fully expend the award received.

The Centers of Disease Control and Prevention awarded \$1,599,037 for the Public Health Infrastructure project. Funding will support new and transformative ways to modernize the public health infrastructure. The project will leave the public health system more prepared to respond to a range of challenges through investments of the workforce and foundational public health capabilities to support the workforce.

The State of Maryland Community Health Resources Commission awarded \$1,600,000 for the

Pathways to Equity program. Funding will address health disparities, expand access to health services, and improve health outcomes in urban, rural, and suburban communities. Specific health disparities include: diabetes, asthma, heart disease, and hypertension, mental health, substance use disorder, maternal and child health, and sickle cell disease.

The U.S. Department of Homeland Security Federal Emergency Management Agency through the Government of the District of Columbia awarded \$50,000 for the Urban Areas Security Initiative. Funding support efforts to prevent terrorism and other catastrophic events and to prepare the Nation for the threats and hazards that pose the greatest risk to the security of the United States.

The Maryland Department of Health awarded \$4,929,619 for the Immunizations and Vaccines for Children program. Funding provides routine immunizations against childhood diseases to children and young adults, ages two months through eight-teen years.

The Maryland of Health awarded \$2,373,256 for the COVID-19 Public Health Workforce program. Funding provides additional relief to address transformative ways to modernize the public health infrastructure. This program is intended to establish, expand, train, and sustain the state and local public health workforce to support jurisdictional COVID-19 prevention, preparedness, response, and recovery initiatives, including school-based health programs.

The Government of the District of Columbia, Homeland Security and Emergency Management Agency awarded \$100,000 for the Public Health Emergency Response program. Funding will be used to build and enhance public health emergency response capabilities.

The Centers of Disease Control and Prevention awarded \$1,599,037 for the Public Health Infrastructure project. Funding will support new and transformative ways to modernize the public health infrastructure. The project will leave the public health system more prepared to respond to a range of challenges through investments of the workforce and foundational public health capabilities to support the workforce.

Department of Social Services

The Maryland Department of Human Services awarded \$20,750 for the Job Access Reverse Commute (JARC) program. Funding will address unique transportation challenges faced by Welfare Reform-Work Opportunities recipients and low-income persons seeking to obtain and maintain employment.

The Maryland Department of Housing and Community Development awarded \$1,305,393 for the Homelessness Solution Program. Funding supports outreach, emergency shelters, homeless stabilization services and the Homelessness Management Information System. Additional appropriation authority in the amount of \$320,593 is needed to fully expend the award received.

The Maryland Department of Human Services awarded \$5,000 for the Statewide Nutrition Assistance Equipment Program. Funds support equipment and supplies that are critical to the operation of a food pantry, soup kitchen or other facilities that provide food or meals at no cost, to those in need.

The Governor's Office of Crime Prevention Youth and Victim Services awarded \$131,478 to support family advocacy, mental health, medical services an interpretive service to child victims and their non-offending caregivers of sexual abuse, sex assault, sex trafficking and serious physical abuse.

Department of Public Works and Transportation

The Maryland Department of Transportation awarded \$34,500 for the Lives Shatter program. Funding provides street smart displays in high schools and other public locations.

The Maryland Transit Administration awarded \$332,819 for the Statewide Specialized Transportation Assistance Program (SSTAP). Funding will be used to replace aging paratransit vehicles. Additional appropriation authority in the amount of \$19 is needed to fully expend the award received. This program requires a county match in the amount of \$91,999.

The Federal Highway Administration awarded \$269,105 for the Rideshare Program. This

program promotes ridesharing in the public and private sectors by helping commuters form carpools and vanpools to relieve highway congestion.

The Maryland Department of Transportation awarded funding \$150,000 to support the Buses and Bus Facilities Program. Funding will support the local match required to support bus replacement, rehabilitation, related equipment, training and apprenticeship programs.

Department of Housing and Community Development

The U.S. Department of Housing and Urban Development awarded \$2,348,562 for the HOME Investment Partnerships Program (PY31). Funding supports a wide range of activities including constructing, acquiring, and/or rehabilitating affordable housing for rent or homeownership or providing direct rental assistance to low-income households. Additional appropriation authority in the amount of \$253,762 is needed to fully expend the award received. Additional appropriation of \$344,311 is needed for program income.

The U.S. Department of Housing and Urban Development awarded \$1,419,842 for the HOME Investment Partnerships Program (PY27). Funding supports a wide range of activities including constructing, acquiring, and/or rehabilitating affordable housing for rent or homeownership or providing direct rental assistance to low-income households.

The U.S. Department of Treasury awarded \$162,119 for the FY 2021 Coronavirus Relief Fund Emergency Rental Assistance Program. The Emergency Rental Assistance Program was created in March 2021 to address the COVID-19 pandemic. Funding provides direct assistance to those struggling with rent or utility payments.

Department of the Environment

The Best Friends Animal Society awarded \$50,000 for the Best Friends Community Cat Program. Funding will provide for the removal of barriers for the live placement of dogs and cats from the Department's Animal Services Division. Activities include promoting adoption events and same-day fee-waived adoptions, incentivizing rescue groups to pull animals from the

Department and emphasizing the placement of the at-risk population, such as large dogs or animals potentially exposed to disease. Additional appropriation authority in the amount of \$14,000 is needed to fully expend the award received.

The Best Friends Animal Society awarded \$6,000 for the Best Friends program. Funding will provide a one-time scholarship for four staff to attend the Best Friends National Conference.

The Best Friends Animal Society awarded \$3,500 for the Best Friends Community Vaccination program. Funding will support at least 400 free combination vaccinations such as distemper, hepatitis, adenovirus and free microchips for dogs and cats owned by County residents.

The Chesapeake Bay Trust awarded \$300,000 for the Urban Trees Award Program. Funding will be used to plant 2,000 native trees in underserved communities.

The U.S. Department of Defense, Office of Local Defense Community Cooperation awarded \$712,800 for the Joint Base Andrews Resilience Study. Funding will provide identification opportunities for climate resilience enhancement to minimize risk to military installation and mission essential functions at Joint Base Andrews and surrounding County communities. This program requires a cash match in the amount of \$79,200.

Circuit Court

The Governor's Office of Crime Prevention Youth and Victim Services awarded \$80,859 for the Improving Survivors Access to Critical Resources with trauma-informed Survivor Defined Advocacy. Funds will provide for response to incidents of family violence, domestic violence and dating violence to develop and strengthen victim services in cases involving such crimes.

The Maryland Administrative Office of the Courts awarded \$7,100 for the purchase and installation of security blast film in public entrances/areas of the courthouse.

The Maryland Administrative Office of the Courts awarded \$7,200 for the MDEC installation for the courthouse.

The Maryland Judiciary's Mediation and Conflict Resolution Office awarded \$71,500 for the Alternative Dispute Resolution (ADR) program. Funds support costs associated with providing mediation and ADR services to court users.

The Maryland Administrative Office of the Courts awarded \$43,709 for moving costs associated with courthouse preparation for the Maryland Electronic Courts (MDEC) integrated case management system and data drop installation.

The Maryland Administrative Office of the Courts awarded \$23,545 for moving costs associated with courthouse preparation for the Maryland Electronic Courts (MDEC) integrated case management system.

Office of the Sheriff

The Maryland Department of Human Resources awarded \$2,065,963 for the Child Support Enforcement Unit within the Office. Funding supports staffing and services related to the service of writs and attachments to person in arrears with child support payments. Additional appropriation is needed for the increase in cash match of \$118,884 and \$230,663 to fully expend the award received.

Non-Departmental

The U.S. Department of Treasury awarded \$100,000 for the Local Assistance and Tribal program to eligible revenue sharing counties which may be used to cover any cost incurred on or after March 15, 2021, for any governmental purpose other than a lobbying activity. The County has elected to use funding for the Department Housing Community Development to conduct a rent stabilization study.
