## **BACKGROUND INFORMATION/FISCAL IMPACT:** (Includes reason for the proposal, as well as any unique statutory requirements)

The Public School Laws of Maryland require the Board of Education and County Council approval of transfers between major State categories. Subsequently, the Prince George's County Public Schools forwarded their Second Financial Review and Transfer Request to the Council for consideration on May 31, 2023. The Board approved the Financial Review on May 11, 2023.

The Request includes budget realignments and transfers between major State categories within the FY 2023 Board of Education Approved Budget. The Request realigns categories within the FY 2023 Board of Education Approved budget to meet current and projected instructional and support service needs for the remainder of the fiscal year. The transfer request maintains a balanced budget and ensures budgetary stability through June 30, 2023. Total revenue and expenditures remain at the Board of Education Approved Budget level of \$2,659,688,770.
