(a) The Box	ard of Appeals shall consist of three (3) [five (5)] members [until December 31
2022,] appointed	by the Council for a term of four (4) years or until their successors are
appointed and du	ly qualified. The term of appointments shall coincide with the term of office of

1	the Council.							
2	[(1) Two additional new appointees to the Board of Appeals shall serve their							
3	terms until December 3, 2023.							
4	(2) Current members of the Board of Appeals shall serve their terms until							
5	December 31, 2022, or until their successors are appointed and confirmed.							
6	(3) In the event a member currently serving on the board is replaced, the new							
7	appointment will specify their terms expiration date to either December 31, 2022 or December							
8	3, 2023.]							
9	(b) The members of the Board of Appeals shall be compensated at the rate of [Seven							
10	Hundred Fifty Dollars (\$750.00)] One Thousand Dollars (\$1,000.00) per month. The Chairman							
11	thereof shall be compensated an additional One Thousand [Five] Seven Hundred Fifty Dollars							
12	[(\$1,500.00)] (\$1,750.00) per year for administrative responsibilities.

14	SECTION 2. BE IT FURTHER ENACTED that the provisions of this Act are hereby							
15	declared to be severable; and, in the event that any section, subsection, paragraph, subparagraph							
16	sentence, clause, phrase, or word of this Act is declared invalid or unconstitutional by a court of							
17	competent jurisdiction, such invalidity or unconstitutionality shall not affect the remaining							
18	words, phrases, clauses, sentences, subparagraphs, paragraphs, subsections, or sections of this							
19	Act, since the same would have been enacted without the incorporation in this Act of any such							
20	invalid or unconstitutional word, phrase, clause, sentence, paragraph, subparagraph, subsection							
21	or section.							
22	SECTION 3. BE IT FURTHER ENACTED that this Act shall replace CB-86-2021 which							
23	was abrogated and of no further force and effect after December 3, 2023.							
24	SECTION 4. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45)							
25	calendar days after it becomes law.
