| WHEREAS, | The Cassidy will be located in Capitol Heights within the Capitol Beltway in | | | |

the Suitland-District Heights Planning Area; and

WHEREAS, The Cassidy will consist of 175 multifamily residential units of all types, including 55 one-, 79 two-, and 41 three-bedroom units for a period of at least 10 years; and

WHEREAS, The Cassidy will be located in Transportation Service Area 1.

WHEREAS, the County Executive has determined, because the Cassidy will have many positive effects on the residential and commercial environment in the Suitland District Heights Planning area, that the public facilities surcharge required under CB-55-2005 and CB-56-2005 should be reduced by 100% for the building permits that will be issued; and will for the foreseeable future, be more than adequately served by the police and fire facilities; and

WHEREAS, the Resolution, subject to the County Council approval, will complete the process required for the full waiver of the public safety facilities surcharge for the Cassidy project; and

WHEREAS, any surcharge imposed within the Transportation Service Area 1 may be waived by the County Executive and County Council, acting as the governing body.

NOW, THEREFORE, BE IT RESOLVED that the public safety facilities surcharge shall be fully waived for the Cassidy.

BE IT FURTHER RESOLVED by the County Council of Prince George's County, Maryland, that the public safety facilities surcharge required in CB-55-2005 and CB-56-2005 is hereby fully waived for the Cassidy project, and building permits that will be issued to the Developer for the dwelling units shall not be subject to the applicable public safety facilities surcharge.
