Additional compensation in the amount of \$14,000 per annum, paid in bi-weekly increments beginning on April 12, 1999; additional compensation in the form of payment to a non-qualified deferred compensation or annuity plan [IRC 457(f)], said payment to be in the amount of \$25,000 per annum, for each year of service after January 1, 1999 through December 31, 2002.
