DIVISION 6. ADDITIONAL REQUIREMENTS FOR SPECIFIC USES.

Sec. 27-548.01.05. Vehicle Parts Store.

Requirements. "Minor installation services" shall only include the removal and (a) installation of wiper blades, removal and installation of light bulbs and headlight bulbs, removal and installation of batteries, diagnostic testing (connecting a computer to the vehicle to obtain repair code information), battery testing, or alternator testing. "Minor installation services" shall not include other automobile or vehicular services." "Minor installation services" shall not occur in any parking space required to satisfy Part 11 of Subtitle 27. There shall be no outdoor storage.
