**BILL**

1 AN ACT concerning

2 County Government Employment

3 For the purpose of creating a ten percent (10%) preference or credit for county residents in the  
 4 competitive filling of vacancies in the Prince George's County Government.

5 BY repealing and reenacting with amendments:

6 SUBTITLE 16. PERSONNEL.

7 Section 16-147,

8 The Prince George's County Code

9 (2011 Edition, 2013 Supplement).

10 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,  
 11 Maryland, that Section 16-147 of the Prince George's County Code be and the same is hereby  
 12 repealed and reenacted with amendments:

13 SUBTITLE 16. PERSONNEL.

14 DIVISION 5. METHODS OF FILLING POSITIONS.

15 **Sec. 16-147. Competitive methods of filling vacant positions.**

16 (a) The Director of Human Resources Management may, in consultation with appointing  
 17 authorities, utilize either of the following methods to authorize the competitive filling of a vacant  
 18 position within the classified service:

19 (1) The certification of eligibles from a promotion register; or

20 (2) The certification of eligibles from a recruitment register.

21 (b) The Director of Human Resources Management and any appointing authority shall give

1 a ten (10%) preference or credit to county residents in the competitive filling of vacant positions  
2 in the Prince George's County Government. In this section, "county resident" has the meaning  
3 set forth in Section 10A-101(14.1) of the Code.

4 SECTION 2. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45)  
5 calendar days after it becomes law.
