RESOLUTION

1 A RESOLUTION concerning

2 Maryland-National Capital Park and Planning Commission

3 For the purpose of transferring certain appropriations and expenditures between certain programs
4 in the FY 2014-15 Operating Budget for the Recreation Fund.

5 WHEREAS, the Annual Budget and Appropriation Ordinance for Fiscal Year 2014-15
6 for the Maryland-National Capital Park and Planning Commission was adopted by CB-33-2014;
7 and

8 WHEREAS, under the provisions of the Land Use Article, Section 18-108, the budget
9 may be amended by resolution by the respective County Councils on their initiative or at the
10 request of the Commission after receipt of recommendations from the respective County
11 Executives, and after public hearing upon reasonable notice to the public; and

12 WHEREAS, there is a need to provide additional funding for two recreation programs,
13 entitled Cherry Lane Boxing, Sports and Fitness, and Laurel Historical Society; and

14 WHEREAS, there is a need to provide funding for six additional recreation programs,
15 entitled Laurel Little League, Laurel Art Guild, Beltsville-Adelphi Boys and Girls Club, College
16 Park Boys and Girls Club, Greater Laurel United Soccer Club, and Laurel Stallions; and

17 WHEREAS, in order to identify funding for these recreation programs, there is a need to
18 decrease funding in the Recreation Fund for a program entitled Laurel Boys and Girls Club.

19 NOW, THEREFORE, BE IT RESOLVED, by the County Council of Prince George's
20 County, Maryland, that the following adjustments to the approved Fiscal Year 2014-15
21 Maryland-National Capital Park and Planning Commission Operating Budget Recreation Fund
22 programs, as approved in CB-33-2014, are hereby made for the purposes set forth above:
