The Legislative Officer provided an overview of the procedural posture of the bill and that it was recommitted by the Council to the Committee on July 24, 2012 after a public hearing was held.

CB-41-2012 Proposed Draft 3 concerns Animal Control – Ear Tipped Cats for the purpose of defining an ear tipped cat; imposing conditions on the trapping and release of ear tipped cats; and generally related to ear tipped cats.

The Legislative Officer provided a summary of the Proposed Draft 3 of the bill to the Committee for discussion. Additional testimony was presented by the DER, Animal Control, the Health Department and the ten (10) members of the public.

The Legislative Officer provided review of a Proposed Draft 2A to the Committee for discussion. Additional testimony was presented by the DER, Animal Control and the County Executive's Office.

The Committee had extensive discussions and accepted the several amendments as reflected in Draft 2.

The Office of Law determined that CB-41-2012 was in proper legislative form.

The Office of Audits and Investigation found that enacted may have a negative or adverse fiscal impact as a result of additional operating costs.

BACKGROUND INFORMATION/FISCAL IMPACT:

This bill defines an ear-tipped cat as a cat that has had a straight line cutting ¼ " off of the tip of the left ear while the cat is anesthetized. A cat who has been ear tipped indicates that it has been neutered and vaccinated.
