#### **Transportation, Housing and Environment Committee**

Committee Vote: Favorable with Amendment, 5-0 (In favor: Council Members Olson, Patterson, Davis, Toles and Lehman)

The Legislative Officer provided a summary of the bill and referral comments that were received. CB-83-2012 concerns the establishment of a complete and green street policy in Prince George's County and generally relating to the County road and sidewalk code by implementing the Metropolitan Washington Council of Government's National Capital Region Transportation Planning Board adopted Complete Street policy for the region.

Susan Hubbard, Vic Weissberg and Gwendolyn Clerkley, Department of Public Works and Transportation (DPWT), offered two amendments, provided additional information and spoke in support of this legislation. Fred Schaffer, Park & Planning staff, provided additional information and spoke generally in support of this legislation but advised

that the Planning Board had not yet reviewed the bill.

The Committee adopted DPWT amendments including: (1) on page 6, line 16 adding "planned" after "All" and (2) on page 6, line 22 adding "as deemed necessary by the Director", that are reflected in Draft 2 of CB-83-2012.

The Office of Law determined that CB-83-2012 was in proper legislative form with no legal impediments to its enactment.

The Office of Audits and Investigation indicated there should not be any negative fiscal impact on the County as a result of enactment CB-83-2012.

### **BACKGROUND INFORMATION/FISCAL IMPACT:**

This legislation seeks to amend the County road and sidewalk code to establish a complete and green streets policy in the County. In May 2012 the Metropolitan Washington Council of Government's National Capital Region Transportation Planning Board adopted a Complete Street policy and template for member jurisdictions to adopt or update their respective policies to safely accommodate motorized and non-motorized users in public right of ways.

11/23/2012: CB-83-2012 (DR-2) was amended on the floor prior to introduction as follows:

On page 6, starting on line 17, after "include", add "environmental site design and".

CB-83-2012 (DR-3) was introduced.
