REPORT: COMMITTEE VOTE: Favorable, 4-0 (Councilmembers: Campos, Davis, Harrison, and Lehman)

This bill will provide for supplementary appropriations to the approved FY2012 Capital Budget in the amount of \$325,000. The appropriation to the Library Renovations 2 Capital Project (HL719163) will amend the approved FY2012 – 2017 Capital Improvement Program (CIP). This adjustment will increase the FY2012 Library Renovation 2 Capital Project in the CIP from \$1,507,000 to \$1,832,000 to reflect the unforeseen expenses to Library Facilities in Fiscal Year 2012.

The Office of Law has reviewed this bill and finds it to be in proper legislative form with no legal impediment to its enactment.

There will be no fiscal impact on the County associated with the enactment of CB-109-2012 as related to the General Fund.
