Committee Vote: Favorable, 5-0 (In favor: Council Members Lehman, Olson, Davis, Patterson and Toles)

CR-29-2012 amends the Prince Georges County FY 2011 and FY 2012 Annual Action Plans to reallocate and approve funding for HOME Investment Partnerships ("HOME") existing and new activities. The total amount to be reprogrammed is \$1,463,897 in uncommitted HOME funds to the County's My HOME homebuyer activities (\$1,020,052) and the HOME Rehabilitation Program II – Single Family Rehabilitation (\$211,113) reflected in Attachment A and B to CR-29-2012.

The Committee reviewed the reprogramming of these funds. Staff oriented the Committee on the comment period and the corresponding supporting resolutions. DHCD Director Eric Brown, Deputy Director Estella Alexander, NSP/My HOME Director Rosalyn Clements and CPD Administrator Shirley Grant provided comments and answered questions by the members of the Committee regarding the reprogramming process, the new HOME allocations and

funding recommendations contained in CR-29-2012.

The Office of Law finds the CR-29-2012 is in proper legislative form and saw no legal impediments to its adoption.

The Office of Audits & Investigations found that enactment of CR-29-2012 will not have a negative or adverse fiscal impact on the County since it deals with federal funds.

This Resolution will amend the FY 2011 and FY 2012 Housing and Community Development Annual Action Plans to reallocate and include existing and new HOME projects and to include narrative requirements. This Resolution requires a minimum of one public hearing under the "County Citizen Participation Plan FY: 2011-2015," because it changes the use of HOME funds from one activity to another and approves funding for new activities.
