BILL

1 AN ACT concerning

2 Renters' Property Tax Relief Supplement

3 For the purpose of requiring the Director of Finance to pay a Renters' Property Tax Relief
4 Supplement to certain residents who qualify for a certain payment under State law.

5 BY adding:

6 SUBTITLE 10. FINANCE AND TAXATION.
7 Section 10-204.03,
8 The Prince George's County Code
9 (2011 Edition; 2014 Supplement).

10 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,
11 Maryland, that Section 10-204.03 of the Prince George's County Code be and the same is hereby
12 added:

13 **SUBTITLE 10. FINANCE AND TAXATION.**

14 **DIVISION 8. TAX ASSESSMENT, LEVY, AND COLLECTION.**

15 **SUBDIVISION 1A. PROPERTY TAX.**

16 **Sec. 10-204.03. Renters' Property Tax Relief Supplement.**

17 (a) The Director of Finance shall pay a Renters' Property Tax Relief Supplement to each
18 resident who qualifies to receive a payment under the State property tax relief program for
19 renters established pursuant to the Annotated Code of Maryland, Tax-Property Article, Section
20 9-102.

21 (b) For each taxable year, the Supplement to each eligible resident under this Section

1 equals fifty percent (50%) of the State payment to the resident.

2 (c) The Director may require each eligible resident to submit an application for the
3 Supplement, and may take any other action necessary to administer the Supplement.

4 (d) The County Executive may promulgate regulations to govern the implementation of
5 this Section.

6 SECTION 2. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45)
7 calendar days after it becomes law.
