Minimum lot size of two (2) acres required. <u>If associated with a church that has approved off-site parking</u>, the total area of the properties shall be a minimum of two (2) <u>acres.</u> A church must provide its tax-exempt identification number when applying for a Detailed Site Plan or a building or use and occupancy permit for an accessory day care center for children.

SECTION 2. BE IT FURTHER ENACTED that this Ordinance shall take effect forty-five
(45) calendar days after its adoption.
