1	SECTION 1. BE IT ENACTED by the County Council of Prince George's County,		
2	Maryland, that Sections 12-201, 12-202 and 12-203 of the Prince George's County Code be and		
3	the same are hereby repealed and reenacted with the following amendments:

7	(a) In this Division the following words have the meanings indicated.		
8	* * * * * * * * *		
9	(2) Electronic cigarette means any electronic device that can be used to deliver		
10	nicotine or other substance to the person inhaling from the device, including, but not limited to,		
11	an electronic cigarette, cigar, cigarillo, or pipe, or any cartridge or other component of the device		
12	or related product. Electronic cigarette does not include any product approved by the Food and		
13	Drug Administration for sale as a drug delivery or medical device.		
14	(3)[(2)] Employee means an individual employed by an owner.		
15	(4)[(3)] Minor means an individual under the age of eighteen (18).		
16	(5)[(4)]Owner means a person engaged in the business of selling or otherwise		
17	distributing tobacco products or electronic cigarettes for commercial purposes.		
18	(6)[(5)]Tobacco product means any substance containing tobacco, including		
19	cigarettes, cigars, smoking tobacco, snuff, or smokeless tobacco.		
20	(7)[(6)]Unpackaged cigarettes means any cigarette not contained within a sealed		
21	original package of at least twenty (20) cigarettes that are designed and intended to be sold or		
22	distributed as a unit.

25	Sec. 12-202. Unlawful distribution.		
26	(a) An owner or an employee shall not:		
27	(1) Distribute any tobacco product or electronic cigarette to a minor, unless the minor		
28	is acting solely as the agent of the minor's employer who is engaged in the business of		
29	distributing tobacco products or electronic cigarette;		
30	(2) Distribute cigarette rolling papers to a minor; or		
31	(3) Distribute to a minor a coupon redeemable for tobacco products or electronic

cigarette.

- (b) A person, who is not an owner, shall not:
 - (1) Buy for or sell to a minor any tobacco product or electronic cigarette; or
 - (2) Buy for or sell to a minor cigarette rolling papers.
- (c) This Section does not apply to the distribution of a coupon which is redeemable for any tobacco product <u>or electronic cigarette</u> when the coupon is contained in a newspaper, a magazine, or any other type of publication in which the coupon is incidental to the primary purpose of the publication, or sent through the mail.
 - (d) A person has not violated this Section if:
- (1) The person examined a driver's license or another valid identification issued by an employer, a governmental entity, or an institution of higher education; and
- (2) The license or other identification identified the buyer or recipient of a tobacco product or electronic cigarette as being at least 18 years old.
- (e) If a minor bought a tobacco product from a vending machine, this Section does not apply to the owner of the vending machine or any other person with control over the vending machine.

DIVISION 9. ENVIRONMENTAL HEALTH

Sec. 12-203. Placement of tobacco products and electronic cigarettes.

- (a) An owner shall display or store the tobacco product <u>or electronic cigarette</u> in a manner which by the design demonstrates the owner's intent that the tobacco product <u>or electronic cigarette</u> is inaccessible to the buyer without the intervention of the owner or the owner's agent. Designs that demonstrate an intent that the tobacco product <u>or electronic cigarette</u> is inaccessible to the buyer without the intervention of the owner or the owner's agent shall include storing or displaying the tobacco product <u>or electronic cigarette</u> as follows:
- (1) Behind the sales counter in a manner which places the tobacco product <u>or</u> <u>electronic cigarette</u> beyond the physical reach of the buyer in the absence of extraordinary extension beyond the sales counter; or
- (2) In a display case which requires seller assistance to gain access to the tobacco product or electronic cigarette contained therein; or

1	(3) In an overhead merchandising rack that is mounted more than six feet above the	
2	floor at the lowest point and from which access to the tobacco product or electronic cigarette is	
3	provided only on the side facing away from the buyer; or	
4	(4) In any place that is inaccessible to buyers of the tobacco product or electronic	
5	<u>cigarette</u> without the intervention of the owner or the owner's agent.

11	Sec. 12-204.01. Child Resistant Packaging of Liquid Nicotine Container Required.	
12	(a) <u>Definitions</u> . In this Section the following words have the meanings indicated:	
13	(1) Child resistant packaging means packaging that is designed or constructed	
14	to meet the child-resistant effectiveness standards set forth in 16 C.F.R. § 1700.15(b)(1)	
15	when tested in accordance with the protocols described in 16 C.F.R. § 1700.20 as in	
16	effect on the date of enactment.	
17	(2) Liquid nicotine container means a container that is used to hold liquid	
18	containing nicotine in any concentration.	
19	(b) Child resistant packaging required. No person shall sell, resell, distribute,	
20	dispense or give away:	
21	(1) any liquid or gel substance containing nicotine unless the substance is in	
22	child resistant packaging; or	
23	(2) any nicotine liquid container unless the container constitutes child	
24	resistant packaging.	
25	(c) Exceptions. This section does not apply to a liquid nicotine container that is	
26	sold, marketed, or intended for use in an electronic cigarette if the container is prefilled	
27	and sealed by the manufacturer and not intended to be opened by the consumer.

3	(a) Eating and drinking establishment shall mean any business for which a use and	
4	occupancy permit is required or has been obtained for a food or drinking establishment pursuant	
5	to Subtitles 4 and 27.	
6	(b) Person shall mean any person, firm, partnership, association, corporation, company or	
7	organization of any kind.	
8	(c) Smoking or to smoke shall mean the act of smoking or carrying a lighted or smoldering	
9	cigar, cigarette, cigarillo, or pipe or lighting a cigar, cigarette, cigarillo, or pipe of any kind.	
10	(d) Electronic cigarette shall mean any electronic device that can be used to deliver

16	Sec. 19-131. Smoking prohibited.	
17	(a) It shall be unlawful for any person to smoke or use an electronic cigarette in any eating	
18	and drinking establishment open to the public except as provided in (b) below.	
19	(b) Smoking is not prohibited by this Section in the bar and dining area of an eating and	
20	drinking establishment that:	
21	(1) (A) Is a club as defined in the State alcoholic beverages law;	
22	(B) Has an alcoholic beverages license issued to private clubs under the State	
23	alcoholic beverages law; and	
24	(C) Allows consumption of alcoholic beverages on its premises; or	
25	(2) Is licensed pursuant to Section 6-201(r)(13) of the State alcoholic beverages law.	
26	(c) Use of an electronic cigarette is not prohibited by this section in a facility that has been	
27	awarded a video lottery operation license by the Maryland Video Lottery Location Commission	
28	under State Government Article, Title 9, Subtitle 1A.

31	Sec. 19-135. Definitions.	

1	(a) Public Housing shall mean any housing in Prince George's County that is:		
2	(1) under the jurisdiction of the Housing Authority of Prince George's County as a		
3	public housing authority as designated by HUD.		
4	(b) Senior Citizen Housing shall mean any congregate housing that:		
5	(1) provides housing under a landlord-tenant arrangement; and		
6	(2) is specifically designed to meet the physical or social needs of elderly individuals;		
7	and;		
8	(3) is under the jurisdiction of the Housing Authority of Prince George's County as a		
9	public housing authority as designated by HUD.		
10	(c) Smoking or to smoke shall mean the act of smoking or carrying a lighted or smoldering		
11	cigar, cigarette, cigarillo, or pipe or lighting a cigar, cigarette, cigarillo, or pipe of any kind.		
12	(d) Electronic cigarette shall mean any electronic device that can be used to deliver		
13	nicotine or other substance to the person inhaling from the device, including, but not limited to,		
14	an electronic cigarette, cigar, cigarillo, or pipe, or any cartridge or other component of the device		
15	or related product.		
16	SUBTITLE 19. POLLUTION.		
17	DIVISION 4. SMOKING IN PUBLIC HOUSING AND SENIOR CITIZEN HOUSING.		
18	Sec. 19-136. Smoking prohibited.		
19	(a) It shall be unlawful for any person to smoke <u>or use an electronic cigarette</u> on the inside		
20	of any public housing or senior citizen housing.		
21	(b) Smoking is not prohibited by this Section in a private home or apartment whose		
22	inhabitants:		
23	(1) Participate in the Prince George's County Department of Housing and		
24	Community Development HOME Investment Partnerships Program ("HOME Program"); or		
25	(2) Participate in the Section 8 Housing Choice Voucher program.

27	SECTION 4. BE IT FURTHER ENACTED that the provisions of this Act are hereby		
28	declared to be severable; and, in the event that any section, subsection, paragraph, subparagraph,		
29	sentence, clause, phrase, or word of this Act is declared invalid or unconstitutional by a court of		
30	competent jurisdiction, such invalidity or unconstitutionality shall not affect the remaining		
31	words, phrases, clauses, sentences, subparagraphs, paragraphs, subsections, or sections of this		
32	Act, since the same would have been enacted without the incorporation in this Act of any such		

1	invalid or unconstitutional word, phrase, clause, sentence, subparagraph, subsection, or section		
2	SECTION 5. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45)		
3	calendar days after it becomes law.
