
The Process: Sec. 29-120.01. Petition for Designation of Historic Properties

- Process initiated by application for Historic Site Evaluation submitted by property owner(s) to Historic Preservation Commission (HPC)
- Historic Preservation Section staff research and present recommendations to HPC and recommend whether property should be classified as an historic site
- Historic Site Designation allows property owners to pursue Historic Property Grant Program and available tax incentives
- HPC sends written notice of hearing to the owners of the historic property, adjoining property owners and to those departments, agencies, organizations, citizens and parties which may have an interest in the proceedings. The property posted as per requirements of Section 29-118(c).
- Within thirty (30) days after the record is closed, HPC makes recommendation on the petition and transmits to Planning Board.
- Within sixty (60) days of receipt of the recommendation, the Planning Board shall hold a joint public hearing with the District Council on the Commission's recommendation.

The Process: Sec. 29-120.01. Petition for Designation of Historic Properties

- Within thirty (30) days after the record is closed, the Planning Board shall submit its recommendation to the District Council.
- Within two (2) months following receipt of the Planning Board's recommendation, the District Council shall make a final decision on the petition.


