#### **BACKGROUND INFORMATION/FISCAL IMPACT:**

Prince George's County, Maryland and Council 67, American Federation of State, County and Municipal Employees (AFSCME), AFL-CIO, and its affiliated Local 241 ("School Crossing Guards") have completed labor negotiations on a one-year labor agreement covering Fiscal Year 2016.
