#### **BACKGROUND INFORMATION/FISCAL IMPACT:**

This legislation will provide supplementary appropriations to Systemic Replacements 2 in the amount of \$5,000,000, Forward Funded Projects in the amount of \$8,486,401, Major Renovations in the amount of \$6,960,401, and Major Repairs in the amount of \$1,526,000 in the Approved Fiscal Year 2016 Capital Budget. These appropriations are necessary to cover budget shortfalls to several capital subprojects. This legislation also decreases the appropriations to the Contingency Appropriation Fund in the amount of (\$8,486,401), Forward Funded Projects in the amount of (\$8,486,401) and Tulip Grove Elementary School Replacement in the amount of (\$5,000,000).
