BACKGROUND INFORMATION/FISCAL IMPACT:

This bill sets forth procedures in the Zoning Ordinance for approval of minor amendments by the District Council for approved comprehensive plans, functional master plans, development district plans, and associated approved Development District Overlay (D-D-O) Zones.

This bill replaces CB-14-2015 and CB-15-2015 which, after discussion at the May 6, 2015, and May 20, 2015, meetings of the Planning, Zoning and Economic Development Committee, were held upon the committee's direction to draft a new numbered bill to expeditiously address the purposes that were embodied within CB-14-2015 and CB-15-2015.

AS PERMITTED BY THE RULES, AND BECAUSE THIS BILL HAS ALREADY BEEN THROUGH COMMITTEE AS CB-14-2015 AND CB-15-2015, NO COMMITTEE REFERRAL IS NEEDED.
