BACKGROUND INFORMATION/FISCAL IMPACT:

This bill alters the procedural prescriptions in the Zoning Ordinance for action on specified development applications—specifically, Conceptual Site Plans, Detailed Site Plans, Comprehensive Design Plans, and Specific Design Plans to shorten and align the development review process—to shorten the time period for consideration and action on an application by the Prince George's Planning Board, to set a limit on remand action on an application by the District Council to one time pursuant to specified grounds within a written Order of Remand, and to shorten the time period for action on development applications by the District Council.
