BACKGROUND INFORMATION/FISCAL IMPACT:

This legislation will amend the Annual Action Plan for Housing and Community Development: Fiscal Year (FY) 2015 and approve the reallocation and commitment of \$850,000 in HOME Investment Partnerships Program ("HOME") funds to a new, eligible activity, the Rainier Manor Phase II senior rental housing project. This Resolution requires a minimum of one public hearing under the "County's Citizen Participation Plan: FY 2011-2015" because it is a new, eligible HOME activity not originally funded or described in Annual Action Plans approved in prior years.
