BACKGROUND INFORMATION/FISCAL IMPACT:

This bill will provide the County with the authority to borrow an amount not exceeding \$48,363,000 to finance the design, construction, reconstruction, extension, acquisition, improvement, enlargement, alteration, renovation, relocation, rehabilitation, or repair of Community College Facilities as approved in the FY2017-2022 Capital Improvement Program (CIP). The projects in this bill are programmed for funding in FY2017.

The amount enabled will provide sufficient funding for each project as required by Section 823 of the County Charter. In accordance with the Charter, if enacted by Council, this bill will be placed on the ballot in November for approval by the legal voters of Prince George's County.
