REPORT: COMMITTEE VOTE: Favorable 5-0 (Councilmembers: Toles, Franklin, Davis, Harrison and Lehman)

This resolution will amend the Salary Plan for Salary Schedule Y for employees in the International Association of Fire Fighters (IAFF), AFL-CIO, Local 1619 (Fire Fighters, Paramedics and Fire Fighter/Medics) and will reflect modifications of the two year Agreement. (July 1, 2013 – June 30, 2015)

The Office of Law has reviewed this resolution and finds it to be in proper legislative form with no legal impediments to its adoption.

The summary of the Salary Plan and the fiscal impact are included in CB-49-2013.

### **BACKGROUND INFORMATION/FISCAL IMPACT:**

This is companion legislation to the bill to approve the collective bargaining agreement between Prince George's County, Maryland and the International Association of Fire Fighters, AFL-CIO, Local 1619 (Fire Fighters, Paramedics and Fire Fighter/Medics), Salary Schedule Y for Fiscal Years 2014 and 2015. This resolution reflects modifications of the agreement. A fiscal impact statement will be provided by the Office of Management and Budget.

The proposed salary plan amendments were submitted to the County Council by the County Executive on June 14, 2013. Pursuant to Section 903 of the Charter, if the Council fails to take final action on the proposed salary plan before August 13, 2013, the salary plan shall stand approved.
